UTILITY - No Report

**BUDGET & FINANCE** 

Mr. Reed stated that the temporary budget has been given. Please look at the EDA dollars for the sanitary sewer, the fund balance of \$500000 from the general fund; this has to be spent to get the funds. Mr. Benson was asking for \$600000 to be placed in the fund. This will be bid on January 8, 2008; can not make a decision now. New council will see the bid, had to agree to get funding, the \$1.1 million proposal is established. This was left out of the budget. Mrs. Colby asked if the storm water money is separate. Mr. Reed stated yes, no EDA funds, this was set up last year.

POLICE, FIRE & TRAFFIC - No report.

Mr. Eric Brown stated in regards to the fire truck, the quoted price is good until the second or third week of January. The bond agent gave a rate and flat rate for the cost of financing. The bank they deal with also sent a proposal for review. \$330000 to borrow at 3.6% APR, just above the bond, with it having an extra \$3000 to purchase the bond. Mr. Heath can decide how to proceed.

#### SERVICE

Mr. Eric Brown stated the ordinance that bids property for the cemetery to be put up for bid. Liberty Township will hopefully be the only bidder. Would like to get this started. Mrs. Colby stated that she was told the city has an ordinance in place; it has donated property in the past.

### REPORT OF THE LAW DIRECTOR

I will not be able to attend this evening's Council Meeting. I have met with the Legal Committee Chairman Randy Heath, and he can report on issues in my place. I wish each of you a Very Happy New Year.

#### ORDINANCES

- o 177-07 This is the Ordinance for the AFSCME Contract. You may go into executive session to "\* \* \* prepare for, conduct or review collective bargaining strategy." However any action must be taken in open session. This contract was received by the administration on December 18, 2007. Council has 30 days to accept or reject the contract. If no action is taken within 30 days the agreement will be approved as presented. There is some question as to when the 30 days commences. I would suggest that you should take action within 30 days of December 18, 2007, the date it was received by the administration. Thus, this gives you until January 17, 2008. Our first meeting in 2008 is on January 14.
- 178-07 This ordinance is to revoke the prior bid award on the old BCS building and start again. This could be an executive session exception, as this may be an issue in which "court action is imminent."
- 179-07 This ordinance authorizes the City to take bids on the sale of property at Hammertown, adjacent to the cemetery. The ordinance states that bids shall be for "cemetery purposes" only. This will protect the reservoir.
- 180-07 This was prepared at the request of Board of Zoning Appeals
   Chairman Eric Brown. He can fill you in on more of the details concerning
   this legislation.
- 181-07 this was on a request from Steve Benson. Exhibit "A" is supposed to be forthcoming, hopefully before the Council meeting. It cannot be passed without the exhibit.
- Ordinances 182-07 through 207-07 are Auditor's Office requests concerning the year end books. Auditor can provide details on these.

Ordinance No. 208-07 – This is a recommendation from the City Investment Board concerning banking services for the City. The Board recommends National City Bank. The Board consists of the Mayor, the Auditor, the Treasurer, and the Law Director. Mr. Humphreys can provide more info it is needed. Can go three readings if 1<sup>st</sup> reading is tonight.

#### LIBERTY TOWNSHIP CEMETERY

 Ordinance 179-07 authorizes bids for the real property, to be limited to cemetery use.

# • SETTLEMENT WITH LUIGINO'S AS PART OF CONSNT DECREE

o Attorney Howarth is handling this and this issue is almost completed.

#### MAXXIMUS/AUDITOR OF STATE

- o At the last meeting Council directed I send a letter to Maximus concerning the contract they presented.
- O As a result of the letter there is some action on this issue. Hopefully the issue with the State Auditor will be resolved in the near future so the City Auditor will know exactly what the Auditor of State will approve. Auditor Humphreys can give more detail and information on this matter.

### WALGREEN'S PROJECT

- The Board of Zoning Appeals has met and approved some variances that were requested by the developer.
- o I do have a copy of a proposed Purchase Agreement. Also, there will be requests for alley vacations, easements, etc. coming in future meetings.
- At the last meeting there was some comments that the City should not be purchasing the real property as part of this project. Perhaps this matter should be sent to a committee for recommendations to Council as a whole.
- o The project is commencing. Mr. Heath can give updates on this matter.

### BCS BUILDING

- o Ordinance No. 178-07 is in the packet for consideration tonight.
- As reported at the last meeting, council previously awarded the contract to John and Melanie Collins. (Ordinance No. 133-07).
- o A simple contact was drafted, and presented to the Collins, and they were requested to sign this contract and commence the work.
- o The contract has not been signed, although requests were made.
- o I sent them a letter asking the contract be signed, or the Ordinance granting them the bid will be revoked. There has been no response.
