Mr. Smith stated the committee met on Wednesday to discuss the installation of an elevator in the Memorial Building. Mayor Heath is trying to find funds, Mr. Sheward is looking for quotes on tuck pointing the building, and then this matter will come to Council.

SAFETY/SERVICE DIRECTOR

Mr. Sheward stated he had the preliminary plans for the elevator, if any member would like to review. Each member received a transmittal letter from Panich & Noel on the preliminary cost. There will be a cost savings by installing the elevator inside of the building, will use some of the auditorium space. We have some ideas on financing. In regards to the antennas on the water tower, passed the ordinance in September, have been working with Mr. Detty and Horizon, all parties have agreed with some minor changes, will be starting the process to finish tomorrow. Mr. Adams asked about the addition to the fire department. Mr. Sheward stated he had spoken with the engineer, will be available soon. Mr. Evans asked if we have an estimate on the elevator. Mr. Sheward stated proposed \$227,000 plus architect and contingency fees around 8%, \$250,000 are our best guess. Mr. Evans asked if this was a small elevator or full sized. Mr. Sheward stated full sized, 1000 lb. capacity. Mr. Smith stated this includes a fire proof stairwell, as well. Mr. Sheward stated it goes from the bottom up to the second floor.
