Mr. Sheward stated they are still working on contracts, completed the ASFME, hopefully present both at the next meeting. Several people have asked about the time frame. There are three ordinances tonight, AMP needs passed, but can't we don't have enough members. The deadline is December 15th; it slipped past, my fault. The other two are fund transfers. Problem arise near Holzer Clinic, Horizon attempted to put cable through the ground, three contractors later, and it went ran through the sewer line, tremendous amount of overtime, tremendous amount of water leaks and some cash in pay, concerned with the weather. Mr. Elliott asks about the Brooks Jones will, referenced a program in Nashville, could a music program be a possibility. Mayor Heath was not sure when this would be finalized. The following is the Report of the Law Director:

ORDINANCES/RESOLUTIONS

- Ordinance 108-10 is an Ordinance from AMP-Ohio authorizing a replacement energy schedule with an optional prepay. The Service Director can provide additional information on this matter.
- Ordinances No. 109-10 and 110-10 are ordinances involving the movement of appropriations and they can be explained by the administration.

• RAILROAD - Fenton Rigging v US Rail and City Suit

- The discovery process on this case is continuing.
- The court has set the next pretrial conference in this matter for late January 2011.
- I will keep you informed as this matter progresses.

CITY v U.S. RAIL

- We are continuing to review and look at a proposed Standard Lease Agreement. Hopefully a final draft will be ready soon.
- I will keep you informed as this matter progresses.

JONES WILL

• We are looking at the process required to receive the bequeath and establish the endowment that has been set in Mr. Jones Last Will and Testament.

- As you will recall from the last regular meeting the gift is to the City of Jackson Recreation Department towards an endowment for "Arts Programs for Youth".
- I will keep you informed as more information becomes available.

MUNICIPAL COURT

- Municipal Court continues to remain a busy place.
- Jail space and funding are major issues in dealing and handling cases.
- I was involved in a Municipal Court sponsored seminar this past Friday. The issue of discussion was Animal Abuse the investigation and presentation of evidence in these type of cases. I believe the seminar was worthwhile and was a service to our local individuals handling these type of cases.
- The next time the Police, Fire and traffic Committee meets I would like to be included on the agenda to update the committee on what is happening in Municipal Court, and the obstacle I face in prosecuting the cases in the court.
