VISITORS

Jennifer Routte, Esq., was present representing US Rail. Ms. Routte discussed a meeting held on August 27th with ORDC, those attending included shippers of US Rail, all expressed satisfaction. Ohio Basic Minerals and Aluchem stated they were integral to their business and it helps to bring more business. She passed out letters, see attached. Mayor Heath had requested a list of all requirements needed if and when a new provider was needed. Despite litigation, US Rail works hard for its shippers; they do not want to put them in the middle. John Buttles was present at the meeting and in the area to view the Meridian building to possibly locate here. Please consider these letters to help, settle please. Work together to improve the community and bring new business to the area. Mr. Smith asked attended from the city. Mayor Heath replied Mr. Fain, Mr. Speakman, Mr. Sheward, Mr. Detty and himself. Mr. Smith asked if it was attended by all customers. Mayor Heath stated not all, the purpose to see when litigation is settled and what will happen. If we change, will have a quality operator in here to run the line. Received inquiries about wheat/ethanol. Would like a sworn statement for the jobs, which they will only come if US Rail is the provider. Spoke with ORDC, we want to keep the railroad, we have shippers help to develop a plan. Mr. Speakman stopped the discussion due to ongoing litigation.

Mr. Brown stated the ordinance for base rates is not here, utility department wanted to do a dry run with new figures. Will present at next meeting. RCAP will be doing sewer rate studies, CT Consultants were contacted but were expensive.

Intention to take the money from that sell and pay down loan on the new truck. The new truck will be here within two weeks. Mrs. Colby asked if there were guidelines for them selling. Mr. Sheward replied no.

MAYOR

Mayor Heath stated before we start the sewer rate study, RCAP will hold a meeting with all council to give a plan. At the ORDC meeting last Thursday, unused funds from the tunnel were allowed to be used toward the stimulus upgrade. The water tower/broadband, no one has approached specifically. This is a benefit to the city and the county. It is in the best interest to approve and an advantage to both and for new business. Business looks at the counties as a whole. Best opportunity to do this, will gain some revenue. Mrs. Colby asked how many communities approved. Mr. Brady stated the commissioners and the City of Wellston is in process and Oak Hill and Coalton are waiting on proposal.

SAFETY/SERVICE DIRECTOR

Mr. Sheward stated Kelly Landrum was requesting new electric service on existing property. Mrs. Colby stated they are supposed to come and ask, per ordinance. Mr. Smith made a motion to approve utilities for Mrs. Landrum, seconded by Mr. Elliott. Mr. Sheward stated Kyle Musick of 27 ½ Ohio Street was requesting a water tap just outside city limits, there is an existing tap on the property this will go to a trailer. Mr. Brown asked if he had other city utilities. Mr. Sheward replied electric. Mr. Smith made a motion to approve a water tap for Mr. Musick, seconded by Mr. Elliott. In a voice vote, all Council agreed.

Mr. Sheward stated Ordinance No. 74-10 was the paving bid no. 2, withdrawn earlier for Robin Hill, rebid with new specs, awarded to Cox Paving, Please approve this contract, and they will be doing all at once. He did receive three bids if anyone would like to see. Ordinance 75-10 is for the mini pumper, as they did purchase. The transfers in the electric department, for professional services, this is to hire a company to do MERK/FERK reporting. Federal government makes it a requirement to report. More than enough work for both myself and Mr. Woltz. Paving of 776 starts tomorrow, grinding and pave the next day. City limits to Cardos, this state project, Shelly and Sands is the contractor. The Amish Barns on Main Street, would like to put in an office trailer. Cannot find regulations, will be put on a foundation. Should this go through committee or let council decide. Mr. Fain suggested to the committee. Mr. Sheward ask Zoning. Mr. Brown stated he will notify Council. Mr. Fain commented on the semi trucks using Chillicothe Street by the school. 10-20 per hour. Mr. Sheward stated he will review. Mayor Heath asked Mr. Brady if every town would be used to get the entire county. Mr. Brady stated he did not know yet. Mayor Heath stated if we grant. Mr. Brady stated they will come back for funding. Mayor Heath stated if not true county wide effort we can withdraw. Mr. Powell stated this is a benefit to the city, could benefit the Police. Mr. Brady stated yes.

Re: Concerns Regarding Potential Changes in Rail Service Jackson, OH Rail Line Ohio Basic Minerals, LLC

Ohio Basic Minerals, LLC (OBM) has been a part of the Jackson, Ohio community for approximately two years. OBM has made a long term commitment to the area and is attempting to create new sustained jobs to support OBM plants in and around the Jackson, OH community.

OBM has several concerns regarding any potential changes to the rail service on the Jackson rail line. The current level of service performed by U.S. Rail has been extremely valuable to OBM. Any potential changes in rail service could be detrimental to OBM's ability to compete in a very competitive market. OBM believes that any potential changes in rail service must maintain or exceed the current level.

As mentioned earlier, U.S. Rail works with OBM to ensure that OBM remains competitive. Some of the services provided by U.S. Rail are as follows:

- U.S. Rail acts as OBM's rail logistics manager by negotiating competitive rail rates with all the Class 1 railroads and other short line railroads.
- U.S. Rail has offered fair and favorable rail rates, which allows OBM to offer competitive rates to potential customers.
- U.S. Rail has offered to supply a private rail car fleet, which OBM is not able to supply on its own.
- U.S Rail has offered to supply locomotive power to the OBM facility as often as needed for switching or shipments.
- U.S Rail has assisted OBM in constructing a rail spur into the OBM facility and will assist, if needed, on any potential extensions.



- U.S. Rail has worked with OBM to negotiate and secure state and federal funding to establish, expand, and to be in compliance with all regulatory agencies regarding rail use.
- U.S. Rail is locally owned and operated, which allows for direct communication with senior management.

As discussed in our meeting, below is a list of tasks/expectations my planner/warehouse staff provided re: their US Rail interactions. This list is not necessarily fully inclusive. It was requested to provide a list in some format to facilitate any effort by the city to identify alternate providers and understand the scope of our relationship with US Rail. I'm not providing this information as a statement of preference to either side of your dispute.

Regardless of any decisions made between US Rail and the city, our base expectation would remain consistent service levels and communication.

- Provider should maintain lines of communication and serve as an interface with CSX (long haul carrier)
- Provider should share (in a timely manner) any holidays, non-work days, other limitations to regular delivery to
- Provider available for weekend deliveries. Willingness also for emergency delivery/pickups.
- Provider able to spot rail cars to our plant unload door as requested (not normal situation)
- Provider should adhere to overall, basic General Mills transportation requirements.
- Provider should be able to communicate rail car ETA to plant.
- Provider should have a means for 24/7 communication to include phone, fax and email.
- Provider should know plant delivery date needs and achieve the same.
- Assuming we will incur periodic charges/penalties (e.g. demurrage), we expect open communication and reconciliation support with any disputed charges. We also expect timely submission to GMI accounts payable, any charges incurred.
- Ensure scheduled inspection, maintenance, and repair of tracks to minimize risk to plant.
- Willingness to have calls/meetings on an as needed basis to resolve concerns, share information, et al.

Not all of the above occur on a regular basis, some are probably more ad hoc. If further detail is needed, please let me know. Thanks.

ORDINANCES/RESOLUTIONS

- Ordinances 73-10 is the ordinance to accept the streets at Jackson Run Subdivision. This was prepared at the request of Councilman Smith. I assume it will go for three readings.
- Ordinance 74-10 is an ordinance to award the paving contract for Robin Hill Lane. The Service Director can answer any questions on this matter you may have.
- Ordinance 75-10 is an ordinance to return the old mini-pumper back to the Firefighters Association. This was part of the process when the new mini-pumper was purchased.
- Ordinance 76-10 and 77-10 are ordinances moving appropriations in the Electric Fund. The Auditor's Office or Service Director can answer any questions concerning this matter.
- Resolution 18-10 is a resolution accepting amounts and rates as determined by the County Budget Commission.

• RAILROAD - Fenton Rigging v US Rail and City Suit
