Jackson City Council met in regular session on Monday, January 10, 2011 at 7:00 p.m. at the Jackson City Council chambers. President Ron Speakman called the meeting to order. The Pledge of Allegiance was given, led by Mr. Brown. The Prayer was given, led by Mr. Powell.

COMMITTEE REPORTS

UTILITY

Mr. Brown stated there was no need for a meeting to discuss the AMP Ohio ordinance, however he did discuss with Mr. Woltz. He feels we need this for a guaranteed cost of electric. Mayor Heath stated AMP Ohio will try to work us in, we only need five votes.

BUDGET & FINANCE – No Report

POLICE, FIRE & TRAFFIC -- No Report

Mr. Elliott stated he had received a call from a Jamestown resident, in regards to the junk cars, no progress being made.

SERVICE -- No Report

RAILROAD – No Report

Mr. Fain stated he will schedule a meeting soon, lease will be ready soon and there is new correspondence from Attorney Richard Lewis to be discussed. He also reported on complaints in regards to crossings in Oak Hill. Mr. Elliott stated he had met with the Historical Society in regards to the depot, would like to encourage the city to repair and save this structure. Mayor Heath stated Mr. Ridgeway is currently repairing. Mr. Speakman suggested the committee meet with the administration and the Historical Society.

BUILDING/RECREATION

Mrs. Colby stated the committee met tonight prior to the regular meeting to discuss the proposed dog park at Eddie Jones Park, it would be located close to the tennis courts and bike path. We would like to move forward and request Mr. Detty

to prepare and ordinance and packet for council. Mr. Powell stated he had a resident ask about extending the bike path. Mayor Heath stated they are currently looking at extending or looping around, reviewing property line with Mr. Woltz.

CITY AUDITOR

Mr. Humphreys complimented the Tourism Board, Mr. Speakman and Mr. Elliott is members, you will have a few more bucks this year, \$64,000.

LAW DIRECTOR

Mr. Detty stated there is an opinion in the packets as per request. Mayor Heath presented a letter, this may resolve some issues. Further stating that while preparing his last two opinions, he received a lot of lobbying on each side, he stated he does research these matters and if he needs you, he will call. Please give him time and space to make the opinion, once given there is no problem discussing.

MAYOR

Mayor Heath stated there has been much concern over the item removed from the contract, opinion contrary with the law, have met with Mr. Detty and Mr. Humphreys. Basically, some members of the union had issues with language; this makes it clear it is the responsibility of the Auditor. Mr. Detty stated as long as you don't change your mind, MOU would help. Mayor Heath stated he will present to the union puts this in the hands of the ORC and ordinance, where it belongs. Mr. Smith and Mrs. Colby ask me to present an explanation of employee changes, see attached.

SERVICE DIRECTOR

Mr. Sheward discussed ordinance number 01-11, paving within the city, state moved the project to this year, there is an error on page 2, should read \$53,668. This is ODOT's estimate, don't know the cost of asphalt, this needs completed by February 4th, please pass by next meeting. He scheduled for the January 24th meeting, Tim with CT Consultants for the next meeting to discuss the consent decree in the sewer. He scheduled Tom with Energy Smart Program at the February 14th meeting. He will have the year end reports for the Police and Cemetery at the next meeting. Mayor Heath added that the contracts only need a second reading tonight.

Mr. Speakman stated they will take from the next year's gasoline tax. Mr. Sheward stated once we agree, we are on the hook. Mr. Smith replied it states that in the ordinance. Mr. Detty will check the language.

Mr. Detty noted the only other change is the name, add historical and educational. Mrs. Colby asked if he had the rules. Mr. Elliott replied yes. Mr. Detty was unsure who made the rules. Mrs. Colby stated the board is to run, the property belongs to the city, so the city does have authorization. Mr. Elliott stated the city is just a pass through.



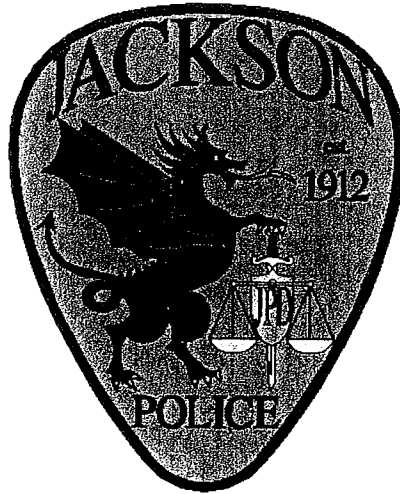

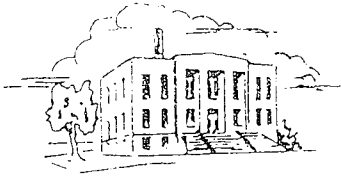

EMPLOYEE CHANGES

Council members Marva Colby and Randey Smith asked me following the last meeting to give a report on personnel changes we have made within the city.

Let me preface this by saying, as always, we examined the financial component very seriously, first and foremost, but it was not our only consideration because that would be very short-sided and could ultimately cost us more than any savings we initially felt could be realized.

The employee changes came about when street and alley laborer Gene Woolum announced his retirement, effective Jan. 16, and street and alley supervisor Ray Rasp announced his retirement effective this spring, although his last day was December 31 due to vacation time accrued.

Since Ray's retirement date is not going to be effective until spring, he has not formally retired but is simply on vacation at this time.

As always, anytime there is a retirement or resignation, we look at whether this is a position we can avoid filling as a result of attrition, which we have done on several occasions.

At one time about five years ago, the street and alley department had a supervisor and seven employees. Now, they have a supervisor and five employees as two positions were not filled when employees left. We considered filling one of them when I first became mayor, but elected at that time to not do so.

As for Gene Woolum's position, the fact this department had already lost two employees in a period of about five years, last year lost all of its summer mowing help, and really needs a certain number of employees to maintain a proper rotation to keep the streets clear of snow, it is was felt that Mr. Woolum's position must be replaced to protect the health and safety of the citizens.

We do a very adequate job in keeping our streets clear. I believe the residents appreciate it and do not want to see that service compromised.

We advertised Gene Woolum's position internally throughout the AFSCME union, and if someone had bid on it from another department where a reduction might have been possible, we possibly could have moved forward without having to make any hires from outside the current workforce.

Unfortunately, though, that did not happen. The only three bids received were from employees of the garbage department, which is currently working at minimum levels.

So to fill this position, which I feel is mandatory to maintain our adequate level of service, we would have to hire someone who is currently working on the garbage truck, and then if no one bids on the opening in the garbage department, which is being advertised, we will have to hire from outside to fill that position, which must be filled as well.

Since the new street and alley department employee will make the same as he makes now, the city will save the difference of Mr. Woolum's salary and the salary of a new employee. One of the key savings here is that the new employee, who I am not going to hire until the new contract is in place, would only be paid 85 percent of the previous new employee's salary. This will be a savings of \$3.74 an hour, or an annual savings of \$7,779.

It is our intention to move Roy Hatten into the supervisor's position when Ray Rasp's retirement becomes official. There will be a \$2,912 savings between Ray's salary and Roy's salary as a supervisor.

When Roy's position becomes open, it is anticipated another employee from the garbage department will bid into the position in the street and alley department, and that will create another savings of \$10,420 when a new person is hired for the garbage.

We are also not going to replace Roy's position as a working foreman and replace it with a laborer. This is an annual savings of \$5,241, which is included in the \$10,420 figure previously stated.

Thus, the total annual savings in salaries, plus the 14 percent saved in PERS contributions which is \$2,955, is $\$7,779 + \$2,912 + \$10,420 + \$2,955 = \$24,066$, which is 79 percent of the salary and wages of a beginning salary.

Thus, we are going to be saving \$24,000 annually, which one of our primary goals was to save money, yet maintain the same level of service or better.

In addition, we feel to make our city operate more efficiently and serve the citizens better, which was our other goal, we took the opportunity to change some personnel assignments for which we worked with our unions to make happen.

With the retirement of a supervisor, much of the initial discussion centered on how to adequately fill that position.

The first aspect that was seriously examined was to review the role of George Bapst, who was the superintendent of the mechanics and the garbage.

George was hired on to the city as a talented mechanic, not necessarily for his supervisory skills. His greatest strength lies in his ability to repair and maintain the city's fleet of vehicles.

Last year, in an attempt to save money, we did not fill a mechanic's position, leaving the city with only one full-time mechanic. While George has been able to help Greg Oliver at times, if his supervisory duties were to have increased to cover the street and alley, he might not have had any time to physically provide the help he had previously.

This might have meant some repair items would have had to be outsourced and the city would have lost money not only in the amount it would take to make the repair, but possibly lose revenue if the out-of-service vehicle in question could not be repaired immediately.

Our first consideration was what was the best use of Mr. Bapst's talents for our city being that some change was going to be forthcoming?

Rather than further compromising our mechanic's department, we decided to take the opportunity to strengthen it and bring it back to two full-time people operating so there could always be at least one person available to handle any situation.

So we ask Mr. Bapst, and he accepted, to relinquish his duties as supervisor of the garbage department and focus his efforts on not only supervising, but also doing whatever physical work is necessary in that department, thus making him a "working supervisor", with both individual work requirements and the overall supervision of that department, a duty that would be somewhat different than the other supervisors,

We then decided to promote Roy Hatten to a supervisory position, to not only supervise the street and alley department, but assume the supervision of the garbage department as well.

This is the way it had been done for many, many years until it was assigned to Mr. Bapst. It also makes sense from the standpoint if a garbage employee is off, we have utilized street and alley employees to cover for them, and this will make the managing of both departments more efficient.

Most of all, Roy Hatten was the most qualified for this position without question. He has worked 15 years for the city's street and alley department, knows in detail the day-to-day operations of the department, and had served as the interim supervisor in the absence of Mr. Rasp.

The employees of the street and alley department were very comfortable with Roy and this would help to produce the best results possible from that department.

As previously mentioned, in another cost savings move, we elected not to fill Roy's position as a working foreman, and replace it instead with a laborer. Although Mr. Hatten's pay will increase by \$4.77 per hour, the difference between Roy's previous salary and the amount paid to the new employee to be hired is even greater, at \$5.01.

It was also examined as to why not leave Roy as just a working foreman and not replace the supervisor's position.

There are several reasons why I think this would not have been the best move for the city.

There are many duties by a supervisor that are unseen, and while taking care of those duties, such as managing the workforce, taking calls from the public, meeting with the service director and auditor's office, etc., he would have not been able to complete the same amount of work as he did before, thus in essence leaving the department compromised in the work it had time to perform, work that I feel needs to be performed.

There are also questions as to whether the OAPSE and AFSCME unions would have opposed such a move, having one employee in a position where he supervises employees within their same union, the questions of who is in charge of discipline and evaluations, etc.

Again, we are saving money, \$24,066 from what are paying now, we are going to be better as we are now by having a working supervisor and two in the mechanic's department again, we have a street and alley supervisor who is the most highly qualified and will make that department better and more efficient than it would have been.

But I truly don't think the compromising of the services that would have resulted was worth what ever additional money that would have been saved.

By doing it the way we did, it also allows us to have a much more clear direction for these departments in the future.

There was also the question as to why not just hire another mechanic now instead and allow George to supervise all three?

First, I would say there is a chance George with his experience could be twice as competent as any mechanic we might get at our beginning rate, and any mechanic we would hire that has the specialized training called for also receives an extra \$5,000 A.S.E. certification pay that a beginning person on the garbage truck would not.

Thus, by having George we would in essence potentially be getting more for our money, not less, and his ability could save us the extra money he is paid just by his efficiency.

Thus, for all of the reasons I have listed, this is the most efficient and effective use of citizen's money in providing them the service I feel they desire and deserve.

We have also added the duties of cemetery superintendent to Robin Bissell's job duties. Robin is one of our most talented and competent employees, and the added duties for her makes her a much more efficient employee for our city as well.

In our goal of balancing services and costs and not putting one ahead of the other, serving the best interests of our citizens, this was certainly the most prudent, cost efficient and cost effective road to travel.
