POLICE, FIRE & TRAFFIC

Mr. Smith reported the committee met tonight, he was unable to attend, and they met to discuss the property for a new building. Mr. Sheward stated building next to the fire department burned, they purchased with hopes to add on. Some preliminary plans estimated the cost to be \$800,000. There are no grant funds available. We have one vehicle outside and two others stored in remote locations. Jeremy Eisnaugle owns the lots behind, will trade for old Gibson property, only the back half of those lots. Mr. Detty and Mr. Kirby have both said we can't trade; we can make an offer, we are asking council to make a decision. There are no specific plans for the Gibson property; Jackson Historical Society did request the property for a Veteran's Memorial. The city has \$25,000 invested in the property. We can build a steel building; just need heated storage and water. Mrs. Colby requested that Mr. Smith call another meeting.

Mr. Sheward stated there had been three AEP shutdowns, and we have experienced an unbelievable amount of lighting strikes, there is equipment damage all over. Mr. Brown commended the crews; we have not been down for long. Mr. Sheward replied the heat had something do with these shutdowns also. Mr. Kitchen commented on the Shade Tree Commission, would like to commend Mr. Fisher, see attached memo. He also asks about the removal of two large stumps from the Jamestown Cemetery.

MINUTES JACKSON CITY SHADE TREE COMMISSION July 14, 2011

The Jackson City Shade Tree Commission held its regular monthly meeting Thursday, July 14, 2011 in the City Council chamber. Chairman Loretta Jones called the meeting to order at 1:05 P.M.. She welcomed new member representing City Council. George Kitchen. Present were Loretta, Roxie Underwood, Alana Billman, and Branch members, Randi Clark and Gary Vollrath. Secretary Underwood read the minutes of the June meeting. They were approved as read.

Communications: Roxie reported she worked 1 ½ hours this morning removing sprouts, etc. from trees on Broadway and Main Streets.

Old Business

- 1. Loretta reported that the Jackson family trees were planted on the day of the flood and one tree was washed out and the mulch as was washed away. Her husband Tom replanted the tree and mulched all 5.
- 2. The trees uptown still need to be mulched. The Launch youth will do it for pay as part of their Relay for Life money. She will write a letter to Judge Mark Musick about his court people helping out.
- 3. We have not had a reply from Service Director Sheward about receiving insurance money for the tree that was broken off at Cardo's.
- 4. In response to the request to look at the tree at 38 East South Street the Commission recommends the tree not be removed. Someone has put a rod in the tree to hold it together.
- 5. Roxie reported that the 5 trees listed in the June minutes were cut down yesterday by our City crew.
- 6. Removal of the 2 large stumps in Jamestown Cemetery the Commission wants to know who owns the cemeteries. George Kitchen will find out.

New Business

- 1. Request for a tree to be planted a neighbor asked for a tree to be planted where the City cut one down across from his home at 115 Florence Avenue.
- 2. Gary reported the need to remove the tree that lost a large limb at the former Franz house, 12 E. Oak Street, the large tree in Manpower Park next to the gazebo, and 2 box elders on Bridge Street, near Broad and West Streets.
