



Dear Mayor and Jackson City Council Members;

I have been asked to provide a summary or overview of the conflict of interest laws in Ohio as they may relate to the City of Jackson. In Ohio, it is unlawful to hold an interest in a public contract if there is a conflict of interest. This law forbids a number of acts with respect to public contract between elected or appointed officers, employees or agents of this City when such an act would constitute a conflict of interest.

The conflict of interest statute has been codified and made a criminal act of the Ohio Revised Code at R.C. Sec 2921.42. These prohibited acts include:

- 1.) Authorizing or employing the authority or influence of the offender's office in securing authorization of a public contract in which the offender or member of his family or a business associate has an interest;
- 2.) Authorizing or employing the authority or influence of the offender's office in securing the investment of public funds in any security with respect to which the offender or any member of his family or any business associate either has

an interest, or is an underwriter, or receives any brokerage, origination, or service fee;

- 3.) During and within one year after the offender's term of office, occupying any position of profit in the prosecution of a public contract authorized by the offender or by any legislative body, commission, or board which he was a member at the time of authorization, unless the contract was left by competitive bidding to the lowest and best bidder;
- 4.) Having an interest in the profits or benefits of a public contract by or for the use of the political subdivision or other governmental instrumentality with which the offender is connected; or
- 5.) Having an interest in the profits or benefits of a public contract that is not let by competitive bidding and that involves more than \$150.00.

There are certain exceptions to the above provisions. For example, in the absence of bribery, fraud, or other bad acts, an ownership interest in a business is generally acceptable if less than 5% AND the interest is fully disclosed to the City. There may also be an exception when the issue involves necessary supplies or services to the City when the supplies or services are unobtainable elsewhere at the same or lower costs, or, the providing of supplies or services is part of a continuous course of dealing that has been established before the public server became associated with the City. This is also permitted when the treatment accorded the City is preferential or the same as accorded others in similar transactions by that public official. Finally, any such transaction must be conducted at arms length with full disclosure to the City and, the public official may take no part in the deliberations or decision of the City with respect any contract.

It is my opinion that the requirement for policing any contract of interest rest with each public employee or official. The City should, however, be on guard for such violations. The penalty for violating the conflict of interest law in Ohio may be a fourth degree felony or, first degree misdemeanor, depending on the violation. Given the serious penalties involved, each public employee official or agent of the City should be weary in avoiding conflict of interest.

In the area of conflict of interest the State of Ohio is willing to give an opinion to any public employee or official wishing to have one. When such an opinion is followed as obtained it will act as immunity to a charge. Therefore, if there is ever a question, you would be well advised to immediately contact the Ohio Ethics Commission and request an advisory opinion. Such opinion should be sought BEFORE any action is taken on a public contract or other matter of potential conflict. When requesting an advisory opinion you will be asked to provide a hypothetical of the perspective conduct.

If you have any questions concerning any matters contained herein, please feel free to contact me. My office is willing to assist any member in contacting the Ohio Ethics Commission and obtaining an advisory opinion.
