JACKSON CITY COUNCIL

Minutes from July 9, 2012 7:00 p.m. Regular Session

Jackson City Council met in regular session on Monday, July 9, 2012 at 7:00 p.m. at the Jackson City Council chambers. President Ronald Speakman called the meeting to order. The Pledge of Allegiance was given, led by Mr. Brown.

Mr. Reed stated that Ordinance 26-12, Library budget, needs passed tonight.

LAW DIRECTOR - No Report

MAYOR

Mayor Heath stated that ten days ago, the city got a swift kick, this tested the citizens, infrastructure and employees. The employees worked tirelessly, by midnight on Friday, 70% of the

power was restored and within 48 hours almost a 100% restored. There were people coming to Jackson because we had electric. Why invest, to be proactive, this saved our residents and businesses. It was extremely hot, electric bills will be higher. He reported that at 6:00 p.m. all call was made to all employees for the emergency. On Saturday, General Mills called and wanted to pay for admission for the pool. For five days it was free, three days were filled to capacity, through the generosity of local businesses. To date, Wellston still has power out. Right now, I am proud to be Mayor, and proud of our employees and our investments.

Mr. Brown stated he was personally without power for seven days, and was glad to see the city a full go within 48 hours. Others came here out of need. Mr. Queen commented the Administration, tree trimmers, electricians, firefighters did a good job.

SAFETY/SERVICE DIRECTOR

Mr. Sheward reported that 500 dump truck loads of brush had been hauled since Friday, the Sextons were hired for three days and this was a tremendous help. Sexton's also allowed the city to haul to their location. Some people are still bringing limbs, please be patient. The cemetery was closed, the broken branches have been cleaned up and belief it reopened today. The employees worked hard, it was very encouraging. We may have to make some adjustments to the budget for overtime. Mr. Speakman stated that in his 22 years at the city, the employees have always responded to a disaster. Mrs. Jones commented she was thankful no one was hurt, we were very lucky. Mr. Sheward stated that Ordinance 27-12 is for the new garbage truck. He stated that the third truck is being worked on more than be being worked, so it is time to buy. Unlike our other trucks, this is low entry, right/left drive. And he actually drove one, explaining further this is heavier, higher compression packer, it cost more, hopefully it will be well worth the cost.

Mr. Kitchen asked about extra tonnage. Mr. Brown asked if seated two employees. Mr. Sheward replied yes to both, and further stated the seats fold down, bigger motor, axils and tires, it cost \$30,000 more than the standard truck. There is \$200,000 in the budget, Ordinance 28-12 and 29-12 are moving the money around. We will be buying from general fund monies with new rates hopefully we will have enough to pay for a new one next time. Mr. Queen asked if this was brand new. Mr. Sheward replied yes, about 60 days for delivery. Mr. Queen asked how we would maintain for warranty. Mr. Sheward replied by taking it to Chillicothe or Columbus. Mr. Brown noted it would be Columbus. Mr. Sheward stated this is not uncommon.

Mr. Sheward stated we had received the new police cruiser, not sure if it is in service yet. Mr. Queen asked how many bids were received on the garbage truck and if any were local. Mr. Sheward replied only one, no one local. Mayor Heath commented in order to move forward tonight, the emergency language needs to be added. Mr. Queen asked if there is \$200,000 in the fund, why are we moving money. Mr. Sheward stated those are budgeted dollars, that doesn't mean its there. Moving the funds from the General Fund to the Garbage Fund. We are not spending \$400,000. Mr. Queen questioned the actual funds, thinking there was a typographical error. Mr. Sheward explained the fund listed is the garbage fund, not certain on the other two, Mrs. Sexton took care of these.
