Regular Session

Jackson City Council met in regular session on Monday, September 10, 2012 at 7:00 p.m. at Jackson City Council Chambers. President Ronald Speakman called the meeting to order. The Pledge of Allegiance was given, led by Mr. Brown. The Prayer was given, led by Mr. Brown.

Mr. Elliott made a motion to approve the minutes from August 27, 2012 regular session, seconded by Mr. Brown. In a voice vote, all members agreed.

#### **VISITORS**

Harold Howe, visited council for a follow up from attending a May/June meeting in regards to flooding. Everybody has been wonderful, no action taken yet. We all agree on the problem and solution, problem is money. This can be alleviated; we have had lots of dry weather. Down by the dog park, there are dams, trees in the creek, same for Hunt Street. Mr. Queen the water is coming your way the next time. Areas of concern are the Manpower Bridge, creek cleaning and erosion at the ball parks and by McDonalds. It is up to council, what is thought of the proposals.

Mayor Heath, we have been getting estimates on projects, funds are available. To remove and replace bridge at Manpower, \$49,000, we need the bridge as we own 35-50 parking spaces at Walgreen's. To convert the railroad bridge on Main/Diamond, \$12,225, McDowell clean up, \$39,850. This took time, Mr. Sheward worked hard, if council wants to move forward, make additional appropriations from the general fund. If the sewer fund ordinance passes we can free up money from the general fund. Major projects, got money this week or so, will help but not a cure, there are legal issues in the Harding Avenue area. Mr. Sheward stated also, submitted application to ODJFS for creek cleaning, don't know if we will get.

Mr. Brown asks about the bid on bridge. Mayor Heath replied it is just an estimate. Mr. Brown stated this needs to be done quick, Cary Brown preached for years, and the area at McDonalds get worse and worse. Mr. Sheward replied we can remove for \$5,000, once removed people must enter from Main Street. Mr. Howe stated he was not here to criticize, do in steps, take it out and plan to replace in the spring. The city is still cleaning up from the wind storm. There is a mess at the dog park, trees down and dams. Mr. Howe stated he had walked all the creeks from St. Rt. 139 to the State Patrol. We should ensure that creek cleaning is in the budget every year, as preventative maintenance. I am just here for an update, the window is short, and something needs done soon. He knows the sewer rate is important, no one wants, but its important so I support, just hoped the numbers were before council.

Mayor Heath asks if council want the numbers. Mr. Elliott stated no meeting was necessary. Mr. Smith stated all members are for moving funds; take the bridge out and creek cleaning. Mr. Queen stated there are trees in the creek on Vine and Logan, lots of trees in the creek; let's move money tonight to appropriate funds.

Mr. Foster asked if the engineering corrected the bridge angle. Mr. Sheward replied he was not sure how to change without buying right of way and that could be costly, will try to straighten as much as possible. The sandstone is coming apart, repaired this summer, now a weight limit. No steel trusses, help in the long term, \$8,000-\$10,000 for analysis every two years. This will take a couple of years, projected to start July 1st, 2014, takes along time and lots of planning. Mr. Brown stated the \$800,000 start to finish floors me. It was \$3 million for the overpass on 35/McCarty, can it possibly be done cheaper. Mr. Sheward wasn't sure, this is the engineers estimate and it's not far off. We can't fix for what our cost would be.
