Jackson City Council met in regular session on Monday, September 24, 2012 at 7:00 p.m. at Jackson City Council Chambers. President Ronald Speakman called the meeting to order. The Pledge of Allegiance was given, led by Mrs. Jones. The Prayer was given, led by Mr. Brown.

Mr. Elliott made a motion to approve the minutes from September 10, 2012 regular session, seconded by Mrs. Jones. In a voice vote, all members agreed.

#### **VISITORS**

Shelly Horvath, Sojourners, spoke on the topic of runaway/homeless youth, see attached. The Generation Now Program, Green Light Program will be having an event on November 7<sup>th</sup> in Jackson. Mrs. Jones asks if this was going to be publicized. Ms. Horvath replied yes.

## SERVICE

Mr. Elliott reported that committee met September 12<sup>th</sup>, with the Administration, Mrs. Jones, Mr. Smith, Mr. Queen and Mr. Kitchen to discuss a flood ordinance. Mr. Reed announced there were little unencumbered funds in the general fund and Mr. Sheward agreed. There is a sizable grant through ODJFS, the level is uncertain and amount and when, it may be next spring. Goes to County, Townships then Municipalities. The City should remove the bridge at Manpower and get estimates to clean McDowell Run and overflow ditches. Mayor Heath gave Mr. Elliott the projected cost, \$7500 McDowell Run, \$9000 overflow ditches, \$5000 bridge removal, which totals \$21,500. We would like to see these projects done, this is a starting point. Hopefully we receive funds from ODJFS. This is not the ultimate solution, but a piece of the puzzle. We also discussed runoff from Jackson High School. Mr. Brown asks if this was the pedestrian bridge at Manpower, or Traffic Bridge and cleaning the creeks to Veterans Drive. Mr. Elliott stated specify flood prevention. Mayor Heath stated the continuing program through ODJFS Jobs Program, picked this area, Salt Creek is being cleaned from the city limits to the county line. We have discussed the urgency of this, not sure how long it will take, 4-6 weeks we will have a better idea. The ideal time is late fall, the foliage is gone. If by the first of December we get no help, we will have to prioritize. We will recheck the budge, if we have funds we will start on the bridge next month. The city auditor is concerned about the surplus in the general fund; we will go through it step by step. The ordinance for allocation, CIB, sales tax revenue down, we lost 18% about \$35,000 estimated. We have to reduce appropriations. Also you have a letter to the Jackson City Schools, see attached. Resolution tonight, this is an emotional issue to deal with, want to do everything we can. We are on the right course. If ODJFS can help, maybe they can do everything, we will stay in contact with them.

Mr. Elliott asks do we not have \$21,500 to spend in the general fund. Mayor Heath stated he thought we did, Mr. Reed raised a red flag, would hope some how. Mr. Kitchen asks do we have process for estimates. Mayor

Heath replied Mr. Sheward is working on some. Mr. Kitchen stated he wants to go all the way to Veteran's. He called three contractors, met with one. Did take the time to walk with Mr. Queen, you cannot believe how much debris there is. Easiest portion to clean is Main Street to Veterans; need to specify what we want done. Probably less than \$21,000. Mayor Heath stated McDowell's Run railroad trestle is quite cumbersome. Mr. Speakman stated make sure they have Workers Comp and are bonded. Mr. Sheward agreed.

Mr. Kitchen stated there is an obstruction on the south side of the creek. The bridge is in bad shape. Mr. Speakman stated don't study it to death, don't give false hope. Mr. Queen asks if there was money left over from Harding Bridge. Mr. Reed replied no, little money in 228 instead of general fund. Mr. Brown asks about the tax revenue. Mr. Reed stated the tax revenue is an estimated fund. Mr. Brown stated he thought it was possible to borrow from electric utility fund and pay back. Can we request \$21,500 with the intention to pay back in twelve months? Mr. Reed replied he is still suggesting using 228; we are not using this year. Mr. Sheward stated we will utilize 228 funds; we can always borrow from utility for the bridge. Mr. Speakman suggested having the administration prepare legislation. Mr. Brown made a motion, seconded by Mr. Smith. In a voice vote, all members agreed. Mayor Heath stated bids/proposals will be in the paper. Mr. Brown asks although done as a proposal; do as bid it drags it out. Wants to see something happen.

## RAILROAD - No Report

Mayor Heath distributed a letter, see attached. The city will continue with the lawsuit. Thanked the ORDC, we had high hopes, saddened with the result. Mr. Queen asks if any payments from US Rail had been received. Mr. Reed replied no.

## BUILDING/RECREATION - No Report

#### **CITY AUDITOR**

Mr. Reed stated Ordinance No. 42/43/44 is cleanup ordinances, please pass. Also there have been several meetings with the investment board, trying to work with CD's, not seeing a windfall.

#### LAW DIRECTOR

Mr. Kirby stated the state, effective next week, and \$25000 to \$50000 on bid requirements. 735.05 amending. Mr. Brown asked does the city have an ordinance that needs updated. Mr. Kirby replied he would check. Also public records seminars, your requirements are satisfied, you can still attend. Mr. Foster asks if \$50000 applied to school boards also. Mr. Kirby replied just municipalities.

#### **MAYOR**

Mayor Heath spoke on the success of the Apple Festival, the Jaycees organized a fabulous Ribbon Cuttings, and people look favorable upon us. Congratulations. There are two ordinances 45/46, pay raises for non-union, so they can have the same increase, and this is past practice. Police chief, Assistant, and Service Director, no increases since being here and consolidated jobs. Not a popular position, he is dedicated and knowledgeable.

Mayor Heath announced Trick or Treat will be held on October  $31^{st}$  from 5 p.m – 7 p.m. in all four communities in the county. This is a neighborhood event, worked well last year. The Jaycees will help.

Mr. Kitchen asked if we were back to square one with US Rail, the plan to go forth. Mayor Heath stated he met with Mr. Kirby and Mr. Martin to finalize.

## SAFETY/SERVICE DIRECTOR

Mr. Sheward thanked the city employees in the clean up of the Apple Festival, lots of effort to keep the streets clean. Mr. Queen asked about money in the Board of Control minutes. Mr. Sheward stated that was a type.




## **Introduction to Sojourners**



Dear Superintendent Howard,

As you are aware, during each of the past two years in the month of May, the area around Huron Street in Jackson has been hard hit by high water as a result of a heavy rainfall.

This has affected an area that stretches from Vaughn Street, where our school system's middle school in located, to an area east of the school system bus garage on Huron Street and even beyond Main Street.

I do believe that both the middle school and the school bus garage each received a level of damage as a result of each of these heavy rainfalls.

While Huron Street is in a low lying area and there have historically been periodic high water problems in that area, the high water instances in each of the past two years, especially in 2011, reached what I believe to be an unprecedented level that I do not believe had ever been reached in the past.

Since these two rain occurrences have directly affected two school system facilities adversely, I am sure the school system, like everyone in the city, would like to address every means to possibly limit such occurrences in the future.

Of course, one of the newer features in the area in the last ten years has been the construction of the new Jackson High School on the highest hill in the area. This was an area that I am sure at one time was primarily covered by trees and vegetation that helped to soak up the water from rains and prevented it from running down the hillsides.

Now, obviously, a large part of the area is covered by buildings and blacktop, with a very limited amount of trees and vegetation to soak up any rains.

While I am sure this was addressed in foresight when the school was built, because of these two rain events and our city's renewed effort to help address the issue, I was wondering if our school system could ask the Ohio Schools Facilities Commission to fund a study that would in hindsight see exactly how the water does run off from the new high school location and could this be contributing to the problem, with the knowledge that there are multiple factors that has most likely created these situations.

I would hope that the Ohio School Facilities Commission would be positively swayed into looking into this since this problem has directly affected two vital buildings owned by the school system.

The Ohio Rail Development Commission (ORDC), the City of Jackson, and US Rail Corporation entered into a Letter of Intent (LOI) dated October 13, 2011. That letter expressed the intentions of all parties for ORDC to accept a transfer of ownership from the City of Jackson of the approximately 70 miles of railroad lines the City owns in Jackson, Vinton, and Ross counties (hereinafter referred to as the "Jackson Line"). It further stated that ORDC intended to enter into a long-term lease agreement with US Rail Corporation for the operation of the Jackson Line.

One of the critical path items outlined in the LOI was that ORDC and US Rail would develop a draft long term lease. As of September 10, 2012, the Ohio Rail Development Commission (ORDC) and US Rail Corporation have mutually determined that such an agreement cannot be reached.

In light of the termination of negotiations, I am informing you that the Letter of Intent signed by the three parties and dated October 13, 2011, is now terminated.

Due to the uncertainty of US Rail's future on the line, ORDC will not provide funding assistance to US Rail for spur or rehabilitation projects along the Jackson Line. Any projects along the line for which ORDC provides funding assistance will be undertaken directly with the City of Jackson.
