### **JACKSON CITY COUNCIL**

Minutes from August 26, 2013 7:00 p.m. Regular Session

Jackson City Council met in regular session on Monday, August 26, 2013 at 7:00 p.m. at Jackson City Council Chambers. President Ron Speakman called the meeting to order. The Pledge of Allegiance was given, led by Mr. Speakman. The Prayer was given, led by Mr. Speakman.

Mayor Heath discussed the Waste Water Treatment Plant tour, see attached. He further stated the greatest challenge is rain water, down spouts, sump pumps connected to the system, this still needs addressed.

RAILROAD - No Report

Mayor Heath discussed the proposed rail road operator, see attached. He then introduced Mr. George Andres, of Indiana and Eastern Railroad. Mr. Andres thanked the Mayor, then stating he was the CEO of Indiana and Eastern Railroad, being the majority owner, he will be working and marketing and appreciates this opportunity. He stated the FRP process is very detailed, thought this through carefully, many plans to create, challenges. We are up to the challenge and eager to prove. We sell good service to customers, rehab line accustom to how we operate. We have been in operation 8 years ago today, \$6 million invested. My partner and I have been in the rail business for 40 years. Thank you again for your trust; we will not let you down.

Mr. Queen asked why this was a 25 year contract. Mr. Dietrich, executive director of the ORDC, replied leased out other assets, problems with public assistance, need time to recoup investment, some leases are up to 99 years. 25 years is the right spot, gives the public comfort, with 5 year check ups, touch points and 2 years for safety and 5 years for performance. Mr. Queen asked who would be responsible for past due property taxes. Mr. Kirby replied in the lease, they are responsible for taxes; we are responsible for arrears, unless we recover from US Rail.

Mayor Heath stated the ordinance had been changed to an emergency. Mr. Kirby further stated an application made to move STB along, we can't proceed without completion, and this developed late Friday. Mr. Queen stated he had not read because it was not an emergency, this is a 20 page contract, hate to vote without reading. Mayor Heath this was developed between Indiana and Eastern Railroad and ORDC, short time it will be in ORDC hands. Basically this moves along the process then turn over to ORDC. Our interest is safe guarded. Mr. Queen is there any chance they won't take over. Mr. Dietrich replied we have full intent to take over, this is contract we have used for state owned contracts, we would sign, and I as director would be comfortable signing. Mr. Queen asked if we get back if contract fails. Mr. Dietrich replied this is just with the operator. Mr. Queen asks they will get all the money. Mayor Heath stated we haven't made any money. Mr. Dietrich stated we won't make a lot either, reinvest in assets, set high for potential. Mr. Brown stated each day we don't sign, we are losing money with US Rail. There will no improvements until new operator takes over. Never intended to make a profit, only meant to maintain the line, support the economy. Right now it's costing us money. Nothing has been paid in over a year, legal fees, this needs put to bed. Mr. Speakman stated the line was only purchased as an economic tool, job retention.

**MAYOR** 

Mayor Heath reported last Thursday we held the first meeting of the Records Commission, in regards to destroying records. There were five departments with list approved, now to the Ohio Historical Society. Hope in a month we will have a reply. Hopefully by the end of the year all unneeded record will be gone.

Mayor Heath stated that he met with the Chief and Assistant Chief about repairs, work is almost completed, and they want to address storage. Also Mr. Sheward and I have discussed possible improvements to the Memorial Building, can't address them all. Would like to remind residents/media we are encouraging folks to clean up property. Officers gave 24 notice to one resident, and then they can be cited. Our office is still receiving complaints about pets, please clean up. Mr. Kitchen's committee has addressed creek cleaning, clean out fallen trees and debris around bridges, with either our people or contracting out.

### SAFETY/SERVICE DIRECTOR

Mr. Sheward announced a Water Plant Tour/Open House on Thursday, August 29<sup>th</sup> at 7:00, Mr. Aldridge will be conducting. Continuing to negotiate with ASFME. The city has two houses on the list for demo. He commented on the new generator filling the hole in the parking lot, this was made in the USA.

Mr. Brown asked about the bridge at Manpower. Mr. Sheward replied they took another job, should be done by December. Mr. Brown asked about the creek at Eddie Jones. Mr. Sheward replied there is a purchase order for Sexton's to take care of. Just clean silt so it will flow with main creek, goes now in opposition, will redirect at the end. No money to straighten out. Mayor Heath stated we had talked about straightening; grant program needed permanent easement and only can go 40 years. Mr. Kitchen commented talked about dirt, ditch and trees. Mr. Sheward replied it's not that simple. Mr. Kitchen stated it's just a ditch. Mr. Sheward replied no, it's a creek, and McDowell's Run.
