#### **MAYOR**

Re: Abandoned and Junk Vehicles

Dear President Speakman, Mr. Sheward and Members of Council;

I was asked at a recent meeting to review the City Codified Ordinances as they relate to junk vehicles and abandoned vehicles and to provide information regarding the ordinance to this Council. The City's Codified Ordinances does address these junk and abandoned vehicles and provides a remedy for such vehicles within the City. In the City of Jackson, junk vehicles and abandoned motor vehicles are treated as a public nuisance. Such nuisances can be ordered to be removed or remedied in accordance with the City's laws on nuisances.

City Code 303.09 prohibits vehicles being left on public or private property without permission or notification. Such vehicles may not be left on private property, such as parking lots, for more than seventy-two hours without permission. Such vehicles may not be left on public property for more than forty-eight hours without notification to the Chief of Police. Vehicles that are so left without permission or notification may be removed. In addition, the person guilty of abandoning the vehicle may also be assessed the costs incurred in disposing of the vehicle and charged with a minor misdemeanor offense.

The City Code also addresses those vehicles that are found to be junk motor vehicles which are stored on private property. Such vehicles may be treated as a public nuisance. Junk vehicles are defined as a motor vehicle that meets any three of the following requirements: 1) is three years or older; 2) is extensively damaged, including but not limited to, missing wheels, tires, motor or transmission; 3) does not comply with all safety laws and equipment provisions for motor vehicles; 4) has a fair market value of \$800.00 or less; and 5) is not running and is not operable so as to be able to be started and driven under its own power. Any vehicle that meets three of the above five requirements is considered a junk motor vehicle and, if "left in the open", may be declared a nuisance and abated in accordance with Jackson City Code. This section does not apply to vehicles stored in a garage or by a licensed towing or salvage facility, in a licensed scrap yard, licensed auto repair garage, etc...

The Director of Public Safety may, in accordance with City Code 303.10(c), give notice to have the vehicle removed as a public notice. The notice provision does give the land owner an opportunity to request and have a hearing.
