Jackson City Council met in regular session on Monday February 10, 2014 at 7:00 p.m. at Jackson Council Chambers. President Ron Speakman called the meeting to order. The Pledge of Allegiance was led by Mr. Hensler. The Prayer was given, led by Mr. Brown.

VISITORS

Mayor Heath introduced the Elks Lodge for a presentation. Dave Channell of the Jackson Fire Department thanked the Elks Lodge for the donation of a stokes basket valued at approximately \$600. This will be very valuable in rescuing people from the woods. This was very much appreciated.

Mayor Heath introduced Danielle Dulaney of the Elks Lodge for another presentation. Danielle spoke about a new project the Elks is doing thanks to a \$10,000 grant they received from the Elks National Foundation. This is called an impact grant. The project is to repurpose used bicycles. The Elks will collect the bicycles and work in collaboration with the auto collision program students at Buckeye Hills and also Daymar College. The bikes will be painted purple to represent the Elks colors. The bike shop will be located at Daymar College. The program is based on want not need. The City of Jackson is also working in collaboration with the Elks to help increase the recycling program. When someone comes to the bike shop and wants a bike, they will be asked to give 2 hours of their time and go door to door to promote the city's recycling program. They can pass out the red recycling bins. There will also be 2 bike clinics held at Daymar College, one in April and one in September.

Mayor Heath thanked the Elks for their presentations.

CITY AUDITOR

Mr. Reed said they had been approached by another credit card provider to handle credit card payments for utilities. He said it costs the city approximately 3% to process credit card payments. Mr. Reed said they might consider having the customers absorb this cost. He doesn't feel the city should have to pay for this. The Utility Committee will schedule a meeting to discuss these matters.

LAW DIRECTOR-No report.

MAYOR

Mayor Heath thanked all of the council members who attended the open house for the Merillat Transition Center. He thanked Tammy Osborne Smith and Julia Coyan of Job and Family Services, Marty Wallace of Buckeye Hills Career Center, Jennifer Jacobs and Sam Brady of Jackson Economic Development, County Commissioner, Paul Haller, Kathy Farber of Appalachian Partnership of Economic Growth, and Larry Kidd of Statewide Jobs Ohio Board, for attending the event. The Mayor felt it was a very information session. Mr. Brown commented it was a very nice setup to try to educate the people losing their jobs at Merrilat.

Another economic effort happened on January 31st, when Ohio South Central Railroad took over. They are still working with the Ohio Rail Commission.

Mayor Heath wanted to stress how important it is for everyone to keep their cars off of the streets downtown when they are trying to plow during snow.

Mr. Queen asked if they had ever looked into trading in the old trucks on new ones. Mr. Sheward said when they buy a new truck, they move the old one to a different area and keep using it until it is worn out and then they sell it at the city auction.

Mr. Queen also wanted to know if they checked into trading in the old garbage trucks and Mr. Sheward said they have, but they won't give them much for them.

Mayor Heath requested to go into Executive Session at the end of the meeting to discuss personnel matters.

SERVICE DIRECTOR

Mr. Sheward said the salt supply is still ok. There is 450 tons left. They have started mixing grit with the salt in areas where there are no storm drains. It seems to be working well.

Mr. Sheward said they may need to come to council with additional appropriations for overtime for plowing. He said if the weather continues as it is, they will probably run out of overtime funds in that department.

The name of the new railroad is "OSCR". He said they want to start checking the tracks, but they can't until the weather breaks.

Mr. Queen asked how they determine who drives the salt trucks. Mr. Sheward said they have set drivers. They have 4 trucks they use for plowing. Mr. Queen asked if they use route maps. Mr. Sheward said they have a standard route they use, but Roy is out and if he or anyone else sees another place that needs plowed worse, they let them know.
