SERVICE –(STREET & ALLEY, RECREATION, BUILDINGS & GROUNDS) –Mr. Foster said his committee met last week and it went very well.

Mr. Kitchen said someone wants to demonstrate the effects of power washing on the Memorial Building. He just wants to demonstrate on a little section on the side of the building. Mr. Kitchen wanted to know if everyone would be interested in seeing this. Mr. Foster, Mr. Queen, and Mr. Hensler were all ok with it. He will need to get with Mr. Sheward to make sure it's ok before he does it.

CITY AUDITOR –Mr. Reed talked about the ordinances that were in the packet. He said 4 of them are for the Flood Mitigation funds. The funds are currently in the old FEMA fund and need to be moved to an account just for that. He said there is also an ordinance for the Library's budget, but it is just a pass through. No money from the city, it just has to be approved by council.

LAW DIRECTOR-Mr. Kirby said he checked out the General Liability Insurance to make sure the quote met all qualifications. He said he checked it out with a consultant in Marietta. The consultant reviewed it and said it met all recommendations of the bid. He had one question about the terms "all autos" and "specified autos", but found out all autos are included so it is fine.

Mr. Kirby said he also checked on the pan-handling ordinance. He said it may be difficult to come up with something that will work, since it violates free speech and asking for money is free speech. Mr. Speakman asked Mr. Kitchen if the Police, Fire, and Traffic committee could try to come up with an ordinance that would work. Mr. Kitchen said they would.

Mr. Queen asked about the insurance pool that was with Mr. Saunders. Mr. Kirby said our limits are higher than what the pooling limits provide. He said there were other carriers that had A+ ratings and had a 3 year contract, but they would not quote due to the dam.

MAYOR-Mayor Heath wanted to give an update on the water leak insurance. He said administration feels it is not going to be beneficial for the city right now. It could end up costing the city money.

Mayor Heath spoke about the e-mail that was passed out to council regarding the Ohio Rail Commission. The ORDC is working with the PUCO to get things done. Please refer to the attached e-mail..

He said Hillcrest Pool has opened and has had over 100 people in attendance every day.

Ball teams are underway and growups are playing ball at the Harding Avenue field.

Solid Waste Management Plan-should have ordinance at next meeting.

Mayor Heath said he is going to get an estimate on the cost of painting the Ice Plant. He should have something in the next couple of weeks.

They have issued one citation for trash around property.

Signs for out of county businesses that are put up around town will be taken down. If phone numbers are listed on them, the people will be contacted.

Mayor Heath said there would be a lot of activity downtown on Saturday due to a large wedding at Christ United Methodist Church and the Civil War re-enactment. The re-enactment will be at the Lillian Jones Museum and will proceed to McKinley Park that evening.

Mayor Heath requested an Executive session at the end of the regular session.

Mr. Queen said he has had complaints about the recycle bins on High Street and wanted to know if they can be moved somewhere else. Mr. Sheward said he hadn't had any complaints, but had people thanking him. It would be hard to move them again, because they had to prepare the place for where they are now.

Mr. Queen wanted to know if he could find out what the flat rate is that Bates Brothers is being charged for water and sewer. Mr. Sheward said he didn't know if that information is allowed to be given out.

Mr. Hensler wanted to let them know the Hilltop property that was washing out has been fixed.

SERVICE DIRECTOR-Osco will be switching in December, so it should give plenty of time to have the lines ready.

AMP classes are being offered to learn more about electric and pricing.

The Logan Street bridge has been repaired.

Mr. Sheward said there were 2 grants awarded through the Safety Intervention Grant Program. \$18,822.00 is the cost of the equipment with \$4,705.00 being the city's portion.

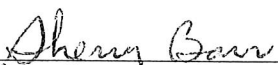

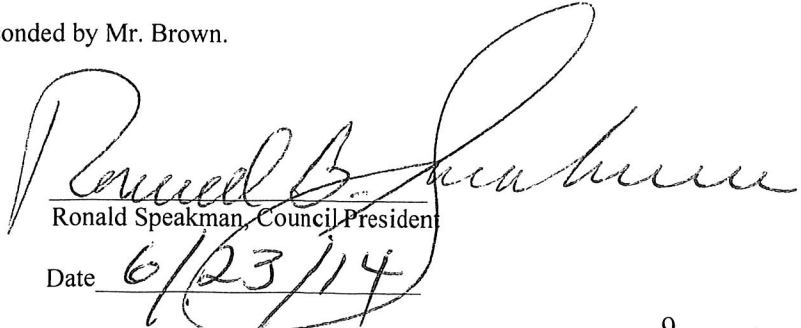

Joshua and David,

Greetings.

I just wanted to touch base with you guys to let you know that ORDC has been working with the Ohio South Central Railroad and the City of Jackson on a variety of issues on the City of Jackson owned rail line, including the crossing surfaces on SR 93 and SR 788.

We had a conference call with George Andres last Friday about how to address the multitude of crossing issues on the Jackson line. Our primary concern is safety, with flasher and gate issues and surface issues that result in safety concerns being our primary focus. We discussed several crossings in some detail including SR 93 and SR 788. ORDC plans to meet with the railroad to get our boots on the ground at these and other crossings on the line in the second half of June. I believe ORDC may be able to use some of our federal highway funds to help out with the SR 93 and SR 788 issues.

David, as ODOT would be involved in anything we do on the SR 93 and SR 788 crossings we will need to have you or another District person there and will schedule our on-site work accordingly. Right now we are looking at June 18, 19, 20, 23, 25, and 26 as possible dates. Can you or your representative make it on any of those days?

Joshua, we would also be happy to have you or another PUCO representative there if that would be helpful to you. Please let me know if the PUCO wants to be there and I can try to make sure our on-site day matches PUCO's schedule.

FYI ORDC and OSCRC have one project funded and are working on a second for next year. ORDC will be investing \$270,000 in ORDC funds to match \$380,000 in ODOT Transportation Alternative Program funds and \$200,000 in OSCRC funds to get the OSCRC line from Richmond Dale to Hamden in FRA Class II (25 MPH) condition. This work will start this year. We are looking for funds for next year to get the Hamden to Red Diamond (Austin Powder) section of line up to FRA Class II also. A major reason that this track rehabilitation project is a top priority is that Austin Powder will be increasing its inbound carloadings of hazmat (mostly ammonium nitrate and some acids) from about 200 to 250 carloads a year to over 1,000 carloads a year. Also, you may or may not have heard that ORDC has been working with the City on a transfer of ownership of the entire Jackson Line from the City to ORDC.

I would like to talk to you gentlemen about what is going on with ORDC and the Jackson Line in more detail. Please give me a call at your convenience. My direct line is 614-644-0309. Thanks.

RE: Ratification of Gallia-Jackson-Meigs-Vinton Solid Waste District's Management Plan

The Policy Committee of the Gallia-Jackson-Meigs-Vinton (GJMV) Solid Waste Management District has completed its development of the mandatory 15-year Solid Waste Management Plan. Enclosed is a copy of the plan, along with a copy of a resolution on which your approval is needed by the District in order to submit the plan to the Ohio Environmental Protection Agency (OEPA) for its final approval.

The timelines for the plan submittal process are set by OEPA, and are very specific. All of the legislative bodies in our four county district have 90 days after they receive this plan to either approve or disapprove it. Therefore, we are asking that your board, council, or commission review the plan and contact us with any specific questions or concerns very soon. The District has just concluded a 30 public comment period and held a public hearing on 5/3/14. There were no comments submitted to the District on the Management Plan during these two steps of the process.

If you have no questions or concerns, please formally approve or disapprove the resolution and return it to the District in the envelope provided. The deadline to return the resolutions to us is September 9, 2014. The District must have either an approved or disapproved resolution on file so we urge you to give consideration to the resolutions as soon as possible. Failure to return your resolution constitutes a "No" vote. Passage of the plan requires 60% approval from all legislative authorities.

GJMV Solid Waste District Policy Committee members from Jackson County are as follows: Jerry Hall, Randy Heath, Roy Arthur, Tom Woltz, Kevin Aston, Greg Ervin, and Dan Lockard.

RE: Switchover to Jackson Municipal Electrical System

Dear Bill:

OSCO is pursuing the switchover to Jackson Municipal Electrical Service in a two-step process.

Phase #1 – OSCO is going to abandon the present AEP electrical feed in the rear of our property that powers the AEP-owned transformer for the electric holding furnace. A new OSCO-owned, electrical transformer for the furnace will be fed from the same AEP main on Athens Street that currently provides power to the rest of the facility. The Jackson facility's electrical service will then be entirely supplied by a single feed on Athens Street. Phase #1 is to be accomplished during the plant shutdown between August 2nd and August 10th.

Phase #2 – The changeover to Jackson Municipal power is planned for early December. This timing synchronizes with expiration of our current electrical supply agreement with AEP Energy. Upon expiration of the agreement on December 1st OSCO will be ready to switchover as soon as plant operations conveniently permit.

OSCO is looking forward to a long and mutually beneficial relationship as a customer of the Jackson Municipal Power Service.

We would like to meet to discuss electrical rates and billing practices. Arrangements for that meeting can be made by contacting Keith Denny, Jackson Plant Manager (740-286-5004).
