VISITORS

Mr. Chris Bice spoke to council regarding his position on the Jackson Fire Department. He stated in January 2015, Dave Channell confronted him about the number of runs he had been on in 2014. He said he would be receiving a letter from Mr. Sheward. His percentage of runs was 3%. He explained he is an employee of the State and cannot miss work to go on calls. Mr. Bice stated on June 18, 2015, he received a certified letter from Mr. Sheward stating his services on the fire department were no longer needed. He said he was told that everyone who was under 50% received a letter. He asked council if they could overturn Mr. Sheward's decision and have him reinstated. Mr. Speakman informed him that council is just a legislative body and that would be an Administrative issue. Council does not have the power to overturn the decision.

COMMITTEE REPORTS

UTILITY

Mr. Brown stated before they get to the end of the year, he would like to have a meeting for a 5 year budget for the utilities. Mr. Sheward stated they are working on the information now.

BUDGET & FINANCE- No report.

POLICE, FIRE, & TRAFFIC- Mr. Kitchen stated they are still going to schedule a meeting regarding golf carts. He will let everyone know when it is scheduled. Mr. Brown stated they made legislation for them a few years ago and they would just have to research it and see what the laws are regarding them.

LAW DIRECTOR

Mr. Kirby stated there are changes to golf carts effective January 2017. The burden is on the city in the future to make decisions about them. They will no longer be considered vehicles.

MAYOR

Mayor Heath informed everyone that Veterans Drive is now open to controlled traffic. He appreciated everyone's patience while it was closed.

He stated he heard wonderful comments about the Apple Festival. It is a community effort and it does give the city prestige. He stated next year parking will have to be addressed on Portsmouth St.

Mr. Speakman requested handicap parking signs be placed close to the Veterans Park in the near future.
