SERVICE -(STREET & ALLEY, RECREATION, BUILDINGS & GROUNDS)-

Mayor Heath gave an update on the Recreation Department. He stated they have been working on the ball fields. The weather has been some factor in the progress being made. The Street & Alley department has not been able to help as much as they used to due to being short-handed. Some of the bleachers are in and being assembled and still waiting on some to come in. The boards for the bleachers at the Eddie Jones field have been bought locally and are waiting on them to get them in. They got a lot done on the Eddie Jones ball fields. The top coating should be in soon, so that can be put down. They are waiting on the fences to get in so they can be put up. All of the teams have sponsors and Mayor Heath wanted to thank those sponsors for their support.

He hopes to have all of the fields in use by the middle of May.

Mayor Heath stated the pool will open the Saturday after Memorial Day. He is working with someone at Job and Family Services to be able to offer a limited amount of passes to children who can't afford them. He wanted to thank American Legion Post 81 for their help with this also.

Mr. Queen asked if they were using the bleachers they bought for the Veteran's Day ceremony and Mayor Heath said they will probably be at the Griff field and coach-pitch field.

LAW DIRECTOR-

Mr. Kirby stated the property at 174 Freeman St. will be auctioned off on May 15th at 10:30 a.m. with no minimum bid.

Mr. Sheward stated they are also checking out a property in Jackson Heights that needs taken care of.

Mr. Foster asked Mr. Sheward about the gas station on State St. to see if he had found out anything. Mr. Sheward stated he thinks the owners live in Portsmouth. He asked Mr. Sheward if he could possibly send them a letter and Mr. Sheward said he will check into it.

MAYOR

Mayor Heath stated there is a resolution in the packets that is for the city to apply for a TIGER grant. It stands for Transportation Investment Generating Economic Recovery. This is a federal transportation grant where \$100,000,000 has been set aside for rural areas. CT Consultants will be making the application. It could be anywhere between two and ten million dollars awarded. It will be a joint application with the county. The priority for use of the money would be McCarty Lane. It could be used for transportation, roadways, walking and bicycle paths, and rail. Some of the applications are due in three weeks, so it would be great if it could be passed tonight.

It is clean-up week this week.

Mr. Brown asked about the progress on the transload station. Mr. Sheward stated they are still working on it.

Mr. Kitchen stated he has seen some activity out at the out Merillat plant.

SERVICE DIRECTOR

Mr. Sheward stated there will be an announcement coming soon regarding Taylor Lumber. They own the old Merillat building, but will be leasing it to another company. They cannot say who it is yet. They have plans for a complete assembly line.

Mr. Sheward stated the painting has started on the Apple tower and if the cover is up, they are painting. Use good judgement when parking during painting.

On June 1st, the Harding Avenue bridge project will begin. The State is the one in charge of the project. It will be closed for several weeks.

Mr. Hensler asked how many employees the new company will have. Mayor Heath thought 35-40, but they aren't ready to hire yet.
