### **OLD BUSINESS**

Mr. Kitchen asked if they could use the \$7,000 left from the FEMA money to tear down the old gas station on Morton St.

Mr. Queen said there are still tanks in the ground there. Mr. Kitchen stated the building could still be torn down. Mr. Sheward stated the money is in the 2016 budget. He said they would have to contact the owner about this.

Mr. Hensler said he spoke to the Law Director regarding changing the Mayor's salary increase effective date from 2020 to 2016 and he said it was legal to do that. He stated there was a possible Ethics violation if the Mayor accepts the increase and he wanted to know if he was going to still accept it. Mayor Heath stated that is something the Law Director would have to address. Mr. Kirby stated if it is an ethics issue, that is something different than the city can do and doesn't have any bearing on whether the ordinance is valid or not. He stated he thinks it is a weak ethics statute. He said from a Prosecutor's standpoint, it would be difficult to prove. He said that would not be his to prove, it would be up to another Prosecutor. As far as what council did and the validity of the ordinance, it is a separate matter.

Mr. Sheward stated everyone that voted "no" on Ordinance No. 82-15, had voted "yes" to purchase the fire trucks and this is part of that loan. Mrs. Sexton said this is the final piece of recording the transactions on the city's books. This has to be made before the books can be closed at the end of the year.
