LAW DIRECTOR-No report.

MAYOR

Mayor Heath stated they received a letter from ODOT stating Main St. repavement project between Bridge and Portsmouth St. has been selected for funding from the Small City's Grant Program. It will pay for 95% of the costs up to \$720, 693.73. It is for 2017, but will start in 2016. Mr. Sheward worked very hard to make the city eligible for this program.

Minutes from July 13, 2015 7:00 p.m. Regular Session

Mayor Heath updated everyone on the Brooks Jones Endowment Fund. When he passed away, he left a \$500,000 Endowment Fund to the City of Jackson Recreation Fund for the purpose of providing arts programs for children. The Advisory Board met recently to review the financial status of the fund and set forth criteria for the future. They voted to make the Endowment principal inactive and requested the city's Investment Board to look into ways to reinvest the money to generate more revenue. The board met and directed Auditor Brett Reed to invest the money in a way to gain more interest. Mr. Reed invested 40% of the funds which he hopes will double the interest in 12 months that it has earned over the past four years. The city schools also received money from the fund and they have also treated the principal as protected.

The Board also feels the money should be used for some physical benefit for the children, such as painting supplies to paint or summer baseball. They are requiring that any entity that applies for this money should have a 501-3C tax status, a non-profit classification.

Mayor Heath stated the electric was out for a little while today, but should be back on at this time.

SERVICE DIRECTOR

Mr. Sheward stated the current ladder truck is back in service. The cost to repair it was \$7,648.96.

Mr. Sheward stated work has begun on McCarty Lane sewer project. There is a problem with signage that needs to be corrected.

Work has also begun on Harding Avenue bridge.

The Main Street hill project does not include replacing bricks with bricks. It will begin with concrete at the foot of the hill and will be asphalt to the top of the hill. It will include new gutters, sidewalks and curbs.

There is a Planning Commission meeting to be held on Thursday, July 16th at 6:00 p.m. to consider the rezoning of the old Knights Inn property from B-3 to R-4.

RE: Solar Field at Hammertown Lake

I am opposed to the proposed solar field installation being located at Hammertown Lake. The City of Jackson acquired some of the land for the Hammertown Lake watershed and built the lake dam in 1953. The lake watershed is only partly owned by the City of Jackson - other private land ownerships make up the remainder of the watershed area. There is not much the City can do to control the water that runs off private property into Hammertown Lake, but the City can, and should, protect its own land that drains into the lake.

Some people look at the City-owned Hammertown Lake Region and see all that land and say, "It's not being used". Well, in fact it is being used - on a continuous basis. The primary and highest use of that land is the watershed for Hammertown Lake. Rain water and groundwater is stored and filtered by the watershed area and released into the lake. There are reasons why Jackson City leaders have kept the City-owned watershed area virtually undeveloped for the past 62 years. Hammertown Lake is an invaluable natural resource asset to the City of Jackson, to its residents, local business and industry, and the local community. Hammertown Lake is the water supply for residential, business, and industrial water customers. The watershed around the lake should be properly managed to help insure the lake can provide the ever increasing demand for safe and abundant water for generations to come. Residential customers value the high quality water they use daily. Business leaders and developers recognize the importance of the abundant water supply the lake provides. If there is any doubt about the importance of an abundant, clean water supply ask the people in California and other western states; or the communities in surrounding regions and states that have been affected by polluted water supplies.

Aside from the obvious benefits of clean, abundant water, the Hammertown Lake Region is an island of peaceful escape from the hectic lifestyles and residential and industrial development surrounding it. People hunt, boat, fish, ride bicycles, walk along Hammertown Lake Road, hike the trails through the woods, observe and enjoy wildlife, enjoy the peace and quiet, star gaze, exercise and train dogs, horseback ride, fly radio controlled airplanes, participate in other light-on-the-land recreational activities and just plain sit and soak in the fresh air and beautiful scenery the lake and surrounding watershed has to offer. These are activities you don't find in the hustle and bustle of downtown Jackson and many residential areas in town. I hope each of you in this room have taken time to drive out to the lake, get out of your cars and appreciate the priceless value of the area.

I am not opposed to the solar field concept, but am opposed to the Hammertown Lake location. This type of development will require excavation to prepare the site. Earth moving and grading will be required, exposing bare soil over a significant number of acres. This can expose the lake to pollution by soil erosion and potentially by petroleum products in runoff from the construction site, and later by drainage of water and potentially by chemicals coming from the solar field site.


How many of you remember the development fiasco that occurred on this very site in 1997? For those of you who do not remember or are not aware, a significant threat to the water quality of Hammertown Lake occurred as the result of a failed attempt to develop a section of land north of the target range on the west side of Hammertown Lake Road. This area, approximately 7 ½ acres was excavated, exposing bare soil. As a result, a significant amount of soil erosion occurred and sediment from that project entered Hammertown Lake. The amount of soil loss was estimated at approximately 100 tons per acre. When pressed to action, the City Administration and Jackson City Council immediately suspended the operation. The City paid a contractor tens of thousands of dollars to try to reclaim the site. The City incurred increased costs for additional treatment of the water drawn from the lake before transmission to utility customers.


The following pages show some photographic images from 1997 of the affected site; sediment that was carried into a stream that flows into Hammertown Lake; and the mud plum that degraded Hammertown Lake and the City's water supply. Note the last image taken in 2012 that shows the land still bears scared after 18 years. It is my understanding this is the same site proposed for the solar field. The water drainage pattern has not changed.


HAMMERTOWN LAKE, JACKSON, OHIO




AREAS EXCAVATED FOR 1997 SOCCER FIELD PROJECT (1997)








Gully erosion on excavated site






Stream showing sediment bar as streams enters Hammertown Lake



Again, in 2008, a proposal was floated to develop 40 acres of land in the same area at Hammertown Lake. The City administration at that time realized the potential negative environmental impacts to the lake and the Hammertown Lake Region and sunk the proposal before it got started.

Here we are 18 years after the fiasco in 1997 and seven years after the City administration sunk a 40-acre development proposal. What has changed?

The current solar field proposal will require excavating and earth moving; erection of power poles and transmission lines. Will the transmission lines have to cross private land? This proposal will open the door for additional solar fields at this site and other sites on the watershed. What's next - a windmill farm? What comes after that? Where will it end? This type of development will have a lasting negative effect on the "light-on-the-land" recreational uses currently taking place on the land and ruin the aesthetics of the area. It will undoubtedly encourage more such development and further and jeopardize the water quality of Hammertown Lake and this special area.

How much money per month will the solar field actually save the average residential customer? Is it worth risking the precious resource the forward-thinking Jackson officials put together 65 years ago?

Have other, less vulnerable sites been explored for the solar field?

The Hammertown Lake Region is already being used for its highest and best purpose, that of supplying clean and abundant water to the City of Jackson's water customers. The current associated "light-on-the-land" recreational uses work well with the lake's intended purpose. All of this makes the Hammertown Lake Region unique from the hustle and bustle of "in town", but are all within a short drive for so many people. The threat to the watershed and lake and the unsightly disruption of the aesthetics of the area are too great a risk. Please don't take this valuable resource for granted and ruin it.

I leave you with some quotes from a City official in a July 1, 1997 Jackson County Press article written by Larry Palletti, headlined, "Soccer field complex a washout"

- "We kept getting assurances...they had things under control."
- "Every time we asked about the apparent damage, we got the same answer "it's going to be okay. We'll take care of it."
- "Frankly, nobody expected it would be so bad."

A total of four (4) bids were received for the aforementioned project on Tuesday, June 16, 2015. All four of the bids fell within the limits established by State of Ohio Law as being awardable. One bid that was submitted by New River Electrical Corporation, 6005 Westerville Road, Westerville, OH 43081 was in the total amount of \$2,267,587.56. The Engineer's Estimate of Probable Cost was published as \$2,751,700 plus or minus 10%, placing the bid amount approximately 15% below estimate.

After performing a review of the bid forms and information provided, as well as checking the bid tabulations, Varo Engineers, Inc. sees no irregularities that would preclude the City of Jackson from entering into contract with New River Electrical Construction. There were a number of simple mathematical differences on all the bids ranging from a total of \$0.05 to almost \$50,000.

Based upon our review and assuming that the City of Jackson has no legal objection or concerns regarding this bid, Varo Engineers, Inc. recommends that the City of Jackson enter into contract with New River Electrical Construction. for the 13.2kV Circuit #2, #2A, & #5 Conversion Rebid Project for an amount of \$2,267,610.72 (the corrected total) at its earliest convenience. Furthermore, the City of Jackson should set aside an amount equal to 10% of this total but not include in the contract, \$226,761.07, as contingency for unknown or changed conditions during the construction period. This would bring the total City of Jackson funding allocation for this project to \$2,494,371.79.
