### LAW DIRECTOR

Mr. Kirby stated he was asked at the last meeting to research the requirements listed in the sewer and water increase ordinances. He stated in regards to the annual review, they are complying with this. As far as the annual notice to customers, they will need to come up with something to send out at the end of each year. It could either be added to the bill or sent in a separate notice. They would probably need to hire a consultant to do the calculations on the cost of that utility. The city has no way of coming up with these figures. Mr. Sheward stated they might want to just amend the ordinance and remove the part that includes the annual notice to customers. Mr. Brown suggested the Utility Committee get together to decide what their recommendation would be.

Mr. Hensler stated he was concerned about how we can bill for something, but can't show what they are billing for. Mr. Brown stated they can show what they are billing for, but not the percentage breakdown of each: operations,

maintenance, and future replacement costs. Mr. Reed stated council controls the rates of the sewer by how the money is spent. He feels there should be a cash balance set aside in each account in future budgets. This is something they need to look at.

### SERVICE DIRECTOR

Mr. Sheward stated they are out to bid for windows for the Memorial Building. The bid opening is February 25<sup>th</sup>.

Mr. Sheward said they have a street bond that is required. If they don't repair the streets the way they should be, they do not get the bond money back. ### **OLD BUSINESS**

Mr. Foster asked Mr. Sheward if he had heard anything else about the burned house on Mound St. Mr. Sheward stated the owner is not being very cooperative. Mr. Kirby stated he is researching the law to see if it would be a misdemeanor if the property is not taken care. Mr. Sheward said the owner will not accept Registered mail. The owner did leave a message on his phone stating the bank has insurance on the house. Mr. Sheward called the bank and they said the insurance will only cover the amount they have invested in it, not the whole property. It is the owner's responsibility. They can hopefully board it up or do something to keep people out of it.

Mr. Kitchen stated there are a couple of houses on Water St. and one has a hole in the roof. He had spoken to someone in Wellston and they are trying to go after rentals. He wanted to know if anything could be done with some of the rentals in Jackson. He spoke to someone at the Health Dept. who was asking if the city was planning on doing anything with the houses on Water St. Mr. Sheward said they had offered them CHIP money, but they do not want any help.

Mr. Brown said we need a solution to the problem of burnt houses not being taken care of. Mr. Sheward said he feels the solution is the landlord needs to take out enough insurance on the property, so if something does happen, there is enough money to take it down. Some kind of ordinance needs to be drawn up to take care of this problem.

Mr. Brown suggested Mr. Foster's committee get together and discuss options there might be to get the problem resolved.

Mr. Reed stated he wanted to clarify the statement he made about the "Then and Now's" not being a big deal. The way the utilities are billed maybe it could be changed for the city, but it hits the first of the month. In order to keep it in this fiscal year, it goes into January or they can keep the Purchase Order open, but it wouldn't give the true year's billings. They bill January 1st and no Purchase Order's are done January 1st. About every department has a "Then and Now" for the utilities. Mr. Brown asked if the billing date can be changed to the 15th of the month. Mr. Reed said he would have to check on it. Mr. Sheward stated they have a lot more "Then and Now's", but unless they are over a certain amount, they don't have to come to council.

Mr. Brown stated Council needs to appoint a Chairman to the Zoning Board of Appeals. He spoke to Mr. Elliott about taking this appointment, but he needs a recommendation from Council. Mr. Kitchen made a motion to appoint Mr. Elliott as Chairman of the Zoning Board of Appeals, seconded by Mr. Hensler. In a voice vote, all members agreed.

### **NEW BUSINESS**

Mr. Sheward stated there is a Planning Commission meeting coming up on February 25<sup>th</sup> to consider two different issues. The time will be announced at a later date.
