#### **BUDGET & FINANCE**

Mr. Hensler scheduled a Budget and Finance Committee meeting for Monday, December 05, 2016 at 7:00 p.m. to discuss the preliminary 2017 budget. If council has any questions regarding the budget, they are encouraged to contact the Administration to get them answered prior to the meeting.

#### POLICE, FIRE, & TRAFFIC

Mr. Kitchen scheduled a Police, Fire, and Traffic Committee meeting for December 12, 2016 at 6:30 p.m. to discuss the Dragoncam. Mr. Foster asked if it would be possible to have a police officer attend the meeting to answer any questions anyone might have or offer their opinion about the Dragoncam. Mayor Heath stated he has reservations about the Dragoncam. He hates to see money go to someone else. He said there haven't been that many accidents due to speeding in the city. He feels the speed trailer helps keep the speed down. Mr. Kirby will see how many speeding tickets have been issued in the last 2 years.

### SERVICE -(STREET & ALLEY, RECREATION, BUILDINGS & GROUNDS

Mr. Foster stated he was up at the swimming pool today and the shelter house outside the pool area is in need of a new roof also. Mayor Heath said this shelter house is used a lot for different things. There will be a metal roof put on this also. Mr. Queen mentioned graffiti on the skate park. Mayor Heath stated they are going to fix this up also. He also said the lights will start being turned off earlier. They will also be putting in a Bocce Court by Spring. Mr. Foster said they are working on the pool liner now.

#### CITY AUDITOR

Mr. Reed said there are some ordinances and resolutions that will need to be passed tonight in order to apply for grants.

He also said they will need to have a meeting on December 28<sup>th</sup>, 29<sup>th</sup>, and 30<sup>th</sup> to close out the year. If everything is past on the 28<sup>th</sup>, they will not need to have the other two. This will be decided at the next meeting.

#### LAW DIRECTOR

Mr. Kirby said they will need to have legislation if they decide to do the Dragoncam. The city currently gets \$88 for every ticket.

#### MAYOR

Mayor Heath stated if anyone has any questions regarding the preliminary budget, please get with Administration prior to the committee meeting so they can try to get the answers. He wanted to thank Mr. Sheward, Mr. Woltz, and Supervisors for all the hard work they have done on the budget.

He wanted to express the concern for the people of Columbus for the situation that happened there today.

Mayor Heath said the citizens need to be informed a little more on how the city operates, like what funds the different departments. He stated \$1.2 million dollars could have potentially been brought in with the Income Tax. The amount of raises they gave this year will have an effect next year on the General Fund of less that \$11,000.00. He said it is their responsibility to educate the citizens about how the city is run and where their money goes.

There was a Tree Lighting ceremony held uptown on Saturday and there was a very nice turnout.

The Clerk stated she had received the annual notice from the Ethics Commission for updated addresses and term dates. If anyone has any changes, please let her know before she mails it back in.

#### **OLD BUSINESS**

Mr. Queen asked if the grant application for the Manpower Park equipment had been submitted yet. Mayor Heath stated no, they are looking at a different one that might provide more money. He asked if it would

be for a boat dock also and Mayor Heath said no. Mr. Queen feels it would bring a lot of people into the city. Mr. Brown said they need to have a sign that states trolling motors only, if they put a dock up. He feels they do need a boat dock.

Mr. Kitchen would like to have the Police, Fire, & Traffic committee meeting to discuss the jail situation instead of the Dragoncam. Mr. Brown thought Judge Musick might not be ready for a meeting yet. He feels they need to discuss the Dragoncam, so they can decide whether or not they are going to move forward with it or not. Mr. Queen mentioned the old Coleman building might make a good holding jail, if they could get the financing for it.

Mayor Heath stated Whitaker Wright will be at the next meeting to talk about a revitalization grant for the city. Match money is not required.

#### **NEW BUSINESS**

Mr. Queen asked if the decorations in the park are donated or how they got them. Mayor Heath stated back in 1996, they had different level of sponsors, depending on how much money they donated. They bought it with the money that was left over. Mr. Queen said people have asked about updating the decorations. Donations would be given to the Chamber and they in turn give it to the city.
