AN ORDINANCE AUTHORIZING THE MAYOR AND THE SERVICE AND SAFETY DIRECTOR OF THE CITY OF JACKSON AND OTHER REPRESENTATIVES OF THE CITY, AS NEEDED, TO ENTER INTO AN AGREEMENT WITH AFSCME/AFL-CIO LOCAL #3619, THE BARGAINING UNIT, FOR CERTAIN EMPLOYEES OF THE CITY OF JACKSON, AND TO EXECUTE THE CONTRACT BETWEEN THE CITY AND BARGAINING UNIT AS REQUIRED AND DECARING AN EMERGENCY.

Third Reading

Mayor Heath stated that less than 9% of the Utility money goes to salaries. Only 30% of the money is from residential customers. .6 of 1% of the increase in wages is from residents or about \$.50 per month. Mr. Queen stated he still feels they should increase the portion of insurance premiums the employees pay. Mr. Sheward stated it says in the contract, the employee's portion can be increased when the insurance cost increases, but the city saved about \$150,000.00 this year by switching to another carrier last year. Mr. Queen stated he also didn't hear any answers to Jon Hensler's questions from the previous meeting. Mr. Sheward stated what Jon was questioning didn't have anything to do with the discussions regarding the contract, it was something completely different.
