# JACKSON CITY COUNCIL Minutes From APRIL 24, 2017 7:00 P.M. REGULAR SESSION

Mr. Brown stated he would like for them to look into body cams for the Officers through Axon. It offers a one year free service.

There is an issue with overlength vehicles parking on residential streets. There is a \$15 fine for this. It is a subdivision violation. It was suggested to paint the curbs in a cul-de-sac yellow. Mr. Kitchen felt that would not look very good.

Mr. Brown also noticed people are parking up on the curb on South St. This probably shouldn't be allowed.

#### SERVICE -(STREET & ALLEY, RECREATION, BUILDINGS & GROUNDS-No report.

Mr. Foster wanted to make sure Mr. Sheward was aware of the new Ohio Revised Code which does not allow plywood to be used to board up abandoned homes.

Mr. Kitchen asked if Mr. Foster had reviewed the draft of the ordinance yet. He asked that another meeting be set in the near future to discuss this again.

#### MAYOR

Mayor Heath stated the month of April is used to get ready for the summer recreation activities. He said the Umpires have gotten paid in the past \$30 if they were licensed and \$15 if they are not. Some of the high school baseball team would like to Umpire this summer, but they would not have a certificate. He would like to ask that if someone is or has been a high school coach grades 9-12, that they be paid the higher rate of \$30.

He said they are about done with the new roof on the pool house at the city pool.

Next Monday the games will start. Everyone needs to watch when the are driving in these areas.

Every team will have been sponsored and Mayor Heath wanted to thank every sponsor.

#### SERVICE DIRECTOR

Mr. Sheward stated this week is Spring cleanup week. It will be picked up on the regularly scheduled day of pickup. Metal items should be sawed up. Probably 3 or 4 foot length can be taken.

Mr. Sheward stated the city received a Certificate of Excellence in Reliability. This was the first time the city has achieved this award.

Mr. Sheward said he feels all of the bricks are either spoken for or paid for. This would be about \$50,000 that can go to the cost of the project.

Mr. Brown asked when McCarty Lane would be started. Mr. Sheward stated it might not get completed this year. It looks like it will go out to bid in May for a July or August start date. They would begin at the railroad and go toward 35 first. The other part would be done next Spring.

Mr. Queen said if anyone is going to do a fund raiser to sell any of the bricks, please let him know. Some people would like to purchase one for memories.

Mr. Queen asked if there would be an amnesty day where tires can be picked up. Mr. Sheward stated the county has a grant that will used to pick up tires and other items.
