Jackson City Council met in regular session on Monday, February 13, 2017 at 7:00 p.m. at Jackson City Council Chambers. President Eric Brown called the meeting to order. The Pledge of Allegiance was led by Mr. Ondera. The Prayer was given by Mr. Hensler.

COMMITTEE REPORTS

UTILITY-No report.

Mr. Elliott asked if the 5 year forecast was done yet and Mr. Sheward stated they are still working on it.

Mr. Sheward said he had a request from property owners at 213 McKitterick Avenue for city utility hookups. Mr. Elliott made a motion to approve the request, seconded by Mr. Kitchen. In a voice vote, all members agreed.

POLICE, FIRE, & TRAFFIC-No report

SERVICE -(STREET & ALLEY, RECREATION, BUILDINGS & GROUNDS-No report.

Mr. Queen asked if the fencing at Harding Avenue Park is going to be replaced or what the plans are for it.

Mayor Heath said it is too hard to mow around, because it is too close to the creek. He said they want to put a permanent fence up at the coach-pitch field. If they ever need one, they can use a temporary fence they have that is very easy to put up.

Recreation signups will start February 28th. This year they are going to have a Pony League for boys and girls ages 13 and 14.

Mr. Elliott would like to have a gate put up at James Cemetery this summer. Mr. Sheward stated the person who was working on it took the parts home and cannot find some of them. They will work on getting this put up.

Mr. Kitchen said 117, 119, 153 Water Street, and the house that burned needs something done with them. He would like to have something put in the paper regarding properties like this. Mr. Sheward stated they have been taking action on the burnt house. There has been a letter sent to the person who owns it. The insurance cannot pay until the city has enough money to tear it down. Mr. Kitchen said he has had people asking about these. Mr. Elliott has some in his neighborhood also. Mr. Kirby said they can publish this information if the property is a nuisance if they have gone through the proper steps. He will check on the ordinance to see how this can be handled.

Mr. Ondera stated he agrees with Mr. Kitchen, but unfortunately it takes money. There was money dedicated to this if the income tax would have passed. Since it didn't, they need to come up with some other way of getting money to take care of these properties. He doesn't feel the Administration should be faulted for this, because they tried to do something to help take care of the problem.

LAW DIRECTOR

Mr. Kirby stated he went to a meeting of the Municipal League recently and they spoke about condemned properties. He spoke with the Mayor of Columbus, who is dealing with the same thing Jackson is. He said it all comes down to money. They are buying the homes that can be fixed up and sold and leaving the really bad ones standing.

MAYOR

Mayor Heath passed out a guide on how the utility funds work. He said a lot of people have questions and this might help answer some of those. There are about 4000 customers. The billing is primarily residential, but most of the money comes from businesses. The businesses help support the residents. Fixed costs are electric, number of employees, etc. There are also variables such as chemicals, etc.

The utilities need to have at least a 5 year plan. The utility system is the key to the future. The upgrades they are doing to the wastewater and electric plants are necessary for future businesses.

The effort of Bill Sheward has saved the city a lot of money through his ability to secure grants to pay for big projects. The success of the utilities is important for our businesses.

Mr. Hensler asked if the power supply cost on the utility bills is a variable cost or fixed cost. Mayor Heath stated it would be a variable cost because it is based on the amount of electric used. Mr. Hensler asked why there isn't a dollar amount on the bills instead of the long list of numbers on the bill. He feels the customer could understand it better if it was on the bill in this format. Mayor Heath said they can get together and discuss it with the Utility Dept. to see if it is an option. The Utility Committee can get together after that to discuss it in more detail.

Mr. Kitchen asked if it would be possible to add a dollar per customer to each utility bill in order to collect money to tear down the blighted properties in the city. Mr. Kirby will check into this to see if it would be legal.

SERVICE DIRECTOR

Mr. Sheward said in the next week, there will be a closure at Bridge St. and Main St. for Columbia Gas in order to move a gas line.

Next week they will be receiving the new police cruiser that replaces the wrecked one. It was purchased from Mark Porter Ford. A local business, Tony Johnson has a firetruck company and has started a new business to equip police cruisers. They will be getting this done by him at the same price as somewhere else.

The electric rate study is still in progress and should have it done sometime at the end of the month.

Mr. Sheward said there is approximately 130,000 bricks that will be coming from the Main St. hill project. The city will keep about a 1,000 of them, but he would like council's permission to sell the remaining bricks. Mr. Kitchen stated the Historical Society had asked for some to make a sidewalk around the Depot.

Mayor Heath asked the public to still remember the businesses around this project area will remain open during the construction.

Mr. Sheward stated the creek cleaning is just about done.

Third Reading

Mr. Elliott gave summarization of the reasons he felt Mr. Sheward should receive his increase. He stated Mr. Sheward is hard working, knowledgeable of city government, has saved the city millions of dollars, etc. He said if they should ever need to replace him, it would be hard to do with the current salary. He is over 4 businesses and many employees, some of which make more than him.

Mr. Kitchen stated he had spoken to Mr. Reed regarding the issue of large salary increases and how they could avoid this problem in the future. They agreed the salaries need to be reviewed more frequently, so they are not trying to catch up by asking for the large increases. There was much discussion by council and different suggestions were made to make this a more amicable request in the years to come. Mr. Brown suggested the Police, Fire, and Traffic committee should review the Fire Chief, and Asst. Fire Chief's salaries. The Administration or an appointed committee could do the other appointed people who are not involved in a union. This should be done at the beginning of each year.
