Mr. Reed requested a copy of the wording from the last meeting regarding the Rents and Right of Way transfers, be inserted as an amendment to the minutes. Mr. Reed read the amendment in its entirety. Amendment is attached.

POLICE, FIRE, & TRAFFIC

Mr. Kitchen stated there is a lot behind the Cambrian that was purchased by the city that could be used for the residents of the Cambrian for parking. There is room for about 8 cars. It has never been used. This needs to be checked out to see if they can make it a parking lot.

Mr. Hensler set another Police, Fire, & Traffic committee meeting for July 10^{th} at 6:00 p.m. to discuss the parking issue further.

SERVICE -(STREET & ALLEY, RECREATION, BUILDINGS & GROUNDS

Mr. Foster asked Mr. Sheward to explain how the street excavation bond works. Mr. Sheward said the private contractor makes a \$1,000.00 deposit and once the street is repaired back to normal, they receive the money back. Columbia Gas makes several of these, but they do a great job and repairing them back to

normal. Mr. Foster stated some of the people they use do a great job. Mr. Foster asked if he feels \$1,000.00 is enough money. Mr. Sheward stated he feels it is. Mr. Foster said if the cut he is talking about isn't fixed in another month, he will bring it back to the table and they will increase it to \$3,000.00. Mr. Ondera asked who keeps track of the cuts. Mr. Sheward said they pay the deposit at the utility office and they tell them where the cut is being made. Columbia Gas does a lot and they don't always know where they are. Mr. Ondera said there is one on the corner of Globe and Star streets that hasn't been repaired for a long time. Mr. Sheward will have it checked out. If anyone sees a place in a street that needs repaired, please let him know.

Mr. Kitchen asked about a house that burned on Mound Street. There was no insurance on the house.

Mr. Kitchen asked about the parking lot behind the old Callahan Hardware building. Are they still going to do anything with it? Mr. Sheward stated they are still going to put up signage.

The creek area along Main Street needs mowed. Can they take the sidearm mower along it? Mr. Sheward said they will get to it.

MAYOR

Mayor Heath stated he had his last game of coaching and he has made a lot of memories and friends.

The Elks hosted a free swim night that was a huge success.

Mayor Heath stated he attended the annual Mayor Association of Ohio meeting last week. He said there were a lot of topics discussed and a lot of cities are facing issues. He said the city has applied for two projects that were \$250,000 through the Appalachian Regional Commission. He said if the Senate does away with certain programs, it can affect the money the city gets from these grants.

SERVICE DIRECTOR

Mr. Sheward stated when it rained last week, water went into the Family Dollar. They are looking for a solution.

They are working on getting the intersection repaired by Family Dollar on Main St. They had some money left over from the Main St. project, so they can possibly use some of that money. They will take the bricks out down to the base and repave and put in new curbs. Hopefully, it can be done by Apple Festival.

August 5^{th} or 6^{th} is when they will award for McCarty Lane and start around September 1^{st} . They start at Veterans Drive to round- about first and finish the rest next Spring.

The budget has increased some. The estimate is a little higher than what they have available in grants. The State is providing an additional \$150,000. They will be replacing the railroad tracks around the 3rd week of July, so McCarty Lane will be closed. The cost of this is by ODOT and Ohio Rail Commission.

Mr. Brown stated he has had a couple of calls regarding a couple of potholes at the end of Veterans Drive. Mr. Sheward said they will check this out again. Mr. Hensler said the railroad tracks on Dickason St. have still not been repaired. They are in bad shape.

Mr. Queen asked if you purchase the perpetual care when you buy a lot at the cemetery. Mr. Sheward stated you do purchase it. If there is a lot purchased and they do not purchase the care, then they will have to pay for the care later.

Mr. Queen asked if an ordinance can go more than three readings. Mr. Kirby said yes. You can suspend rules to lower it, but he has never found anything that says you can't suspend it to go longer than three readings.


