He said he has heard feedback from the public and it is not all negative. He said some have already started working on their properties. Mr. Kirby said they can put them in the paper, but they can't pick and choose.

There would have to be certain guidelines. It would be a good idea to adopt an ordinance by which the information is published. There seems to be money to buy things, but no money for the upkeep of the streets and sidewalks. Mr. Kitchen said they need to find some money for these projects.

### MAYOR

Mayor Heath stated he wanted to clarify a Social Media post that Mr. Queen had posted regarding creek cleaning and employee raises. The only money that can be used for creek cleaning is General Fund money. The money for raises does not come from the General Fund, except for some in the Police Department. They are currently working on creek cleaning and there was \$25,000 budgeted for this. There is no way they can prevent flooding from ever happening again. When there is a good hard steady rain, it is going to flood.

One of the objectives of the Revitalization Grant is to try to fix some flooding in these areas. The third meeting regarding the grant will be held March 14<sup>th</sup> at 7:00 p.m. at the Senior Citizens building.

Mayor Heath stated March 14<sup>th</sup> will be the last sign-up for the summer recreation program. If they can't come tomorrow night, they can come to the Mayor's office and sign-up. They will probably pick teams over the weekend. The cost is \$25 for ages 8 and under and \$30 for ages 9 and over. There is currently a little less than 300 signed up.

Travis Ruckle is the new Coordinator for the summer program this year. He will oversee the boys and Mayor Heath will oversee the girls.

The resolution that is being read tonight is for the repairs and upgrades of the play area at the Manpower Park. He is not sure how much the grant will be, but it could possibly be reimbursed at 75% of the money that is allocated for our area. It might be about \$25,000.

Mayor Heath mentioned the parking situation that was discussed at the last meeting and said the Police Department had written 3 citations for parking on the wrong side of the street. The Police, Fire, and Traffic Committee might want to review the ordinance for this and see if there are any changes they want to make.

Two weeks from today, they should start working on Main Street. He is still checking out the bricks that will be dug up. They will be stored down by the City garage and surrounded by a fence, so nobody can take them.

Mr. Kitchen stated he had received a message from a couple of citizens complaining about the old service station at the corner of Bridge and State Streets. They said the trash around it needs to be cleaned up. Mr. Kirby stated it is a criminal offense to litter, so the owner could be cited. The city should be able to clean it up and then they should be able to bill the owner for the cost.

Mr. Ondera mentioned the parking citations and wondered if they were actually given a ticket or not. He feels if this has not been enforced in the past, then he feels the first time should just be a warning. Mayor Heath agreed.

#### SERVICE DIRECTOR

Mr. Woltz also feels there needs to be a meeting of the Police, Fire, and Traffic Committee regarding the parking issues. He feels there might need to be some changes made to the current legislation.

Mr. Brown thought it would be better to finance the truck instead of paying for it all at once. He said that way they could use some of the money to pave some of the streets. Mayor Heath said he will talk to Mr. Sheward and Mr. Reed to see what their feelings are. Mr. Woltz said since winter is about over, maybe they could wait a little while on it.
