Mr. Queen asked if there were any updates on the Revitalization Grant. Mayor Heath stated there is one, but he isn't sure when it is. He will check on it.

Mr. Kitchen asked Mayor Heath if he had heard anymore on the bike path legislation. Mayor Heath said it had to be passed by the Commissioners and it did not pass.

SERVICE DIRECTOR

Mr. Sheward stated they are planning a celebration for the 200th anniversary of the City of Jackson.

The Firefighter's Association and other service clubs have been planning events for July 3rd. The fireworks display will be \$15,000.00 this year. There will be activities in Manpower Park. Wal-Mart is donating cupcakes for the 200th anniversary. There will be a scavenger hunt sometime over that weekend. Everyone who participates in this will receive a commemorative coin. There will be 200th anniversary banners hung through the city. If anyone has any ideas for other activities, please get with Mr. Sheward. They also welcome donations that can be sent to Jackson Firefighter's Association, 145 Broadway St. He would like to have 6 more banners. The cost is about \$150 each.

Mayor Heath said the Chamber of Commerce will sponsor the Community Concert which will be held at the Markay on July 2nd. They will also sponsor the July 4th parade to be held on July 3rd. The 5K run will be held on Tuesday morning July 4th.

Mr. Brown stated the grass in front of the new Dollar General looks terrible. Mr. Sheward stated the 10th is the day when it has to be mowed. If it isn't mowed by then, they will talk to them.

Mr. Queen asked when they would receive the grant for Manpower Park equipment. Mayor Heath stated it would not be until the Fall.

The equipment is to be upgraded and replaced. There will also be a sidewalk built. Eventually, he would like to have a circular sidewalk so people can use it to walk around for exercise. They would also like to fix the drainage problem.

Mr. Hensler said a couple of Trustees had contacted him regarding the storage of old tires when they are collected. The county received a grant to take care of these tires and they need a place to collect them. Mr. Sheward stated it is a hassle for the city to do it, but he told them he would let them if they couldn't find anywhere else.




