ORDINANCE NO. 02-18

AN ORDINANCE CALLING FOR THE PLACEMENT ON THE BALLOT OF THE MAY 8, 2018 PRIMARY ELECTION IN THE CITY OF JACKSON, OHIO, BY ADVISORY ELECTION, THE ISSUE OF THIS COUNCIL ENACTING AN INCOME TAX AT THE RATE OF 1% FOR THE PURPOSES OF PROVIDING ADDITIONAL FUNDING FOR THE OPERATION OF THE CITY POLICE DEPARTMENT AND DECLARING AN EMERGENCY.

First Reading

Mr. Ondera made a motion to adopt the ordinance, seconded by Mr. Kitchen. In a voice vote, all members agreed.

Mr. Ondera questioned the wording of "annual levy of 1%." Mr. Kirby said that just means it is an annual tax.

Mr. Kirby said there were some questions with what was passed, but all of them have been answered.

Mr. Kirby said this is an advisory election for municipalities only. It is asking citizens for their advice. It just adds "belts and suspenders" to the other one.
