#### VISITORS

#### APPROVAL OF MINUTES

Mr. Elliott made a motion to approve the minutes for the regular meeting on October 28, 2019. It was seconded by Mr. Foster. In a voice vote all members agreed.

Mr. Aldrich made a motion to approve the August Auditor's report. It was seconded by Mr. Kitchen. In a voice vote all members agreed.

#### **COMMITTEE REPORTS**

**UTILITY-** The Hill family requesting utility services from the city for 385 and 399 Florence Avenue. The Hill's purchased these properties and plan to build on them. They need council's approval for city services since they are outside of the city. Mr. Ondera made a motion with Mr. Elliott seconding it to approve city utilities for these addresses. In a voice vote all members agreed.

BUDGET & FINANCE- The Temporary budget for 2020 is available for the first reading tonight.

**POLICE, FIRE, & TRAFFIC-** In the month of November two council members must be appointed to The Fire Fighters Dependency Fund board. Mr. Foster and Mr. Peters are the only returning councilmen. Mr. Ondera nominated them both to the board with a second by Mr. Kitchen. In a voice vote all members agreed. This Wednesday, November 30<sup>th</sup> at 6:00pm will be a meeting that Mr. Foster and Mr. Peters must attend.

SERVICE – (STREET & ALLEY, RECREATION, BUILDINGS, & GROUND) Mr. Foster turned it over to Mr. Sheward to discuss the cemetery ordinances 25-19 & 37-19. Mr. Sheward said he felt Ordinance 37-19 needed to be rescinded/removed. He said there are hundreds of lots with back keep amounts totally over a million dollars. He believes this is too much money for the city to forgo. Some council men made the argument that many of the lots are forgotten about and/or not going to be used. People who owe a \$1000 in back fees could just buy another lot for \$400 + the \$75 perpetual care fee. Questions asked were: Should we just make one set fee? How many lots could be resold?

Mr. Peters made a motion for law director to make an ordinance to rescind/replace ordinance 37-19 to reinstate annual care. Mr. Foster seconded it. In a voice vote all members agreed.

Mr. Elliott asked about the Christmas bulbs that were burnt out. Mayor Heath said they are working to fix them. If anyone sees one out to call for a work order and they will be fixed.

SERVICE/SAFETY DIRECTOR – Mr. Sheward said the concrete work is finished at Manpower Park. There are orange cones covering where there are pipes and bolts sticking up. These are for the electric portion that isn't finished yet, and they don't want people to trip over them during the tree lighting ceremony.

Several properties have been torn down. One is down on Water St. and a second one is in the process on Water St. One has come down on Cross St. also.

OAPSE has a tentative contract and will have explanations at the next meeting.

There will be a meeting by the planning commission at 6:30 on 12-23-19 before the regular council meeting. They are considering rezoning a 5 acre lot from industrial to commercial for the building of a new facility for the senior citizens.

The demolition at 165 Broadway is still in slow progress. Mr. Peters asked if anyone reviewed the historical ordinance. Mr. Sheward said he did not. Mr. Kirby said it needs to be brought back in the codified ordinances if we want to keep it.
