### ORDINANCES AND RESOLUTIONS:

#### **ORDINANCE 34-20**

AN ORDINANCE AUTHORIZING AN INCOME TAX AT THE RATE OF 1.5% FOR THE PURPOSES OF STREET AND SIDEWALK REPAIRS AND/OR REPLACEMENT, AND FOR MAINTENANCE OR CONSTRUCTION OF OTHER CITY INFRASTRUCTURE, THE DEMOLITION OF UNSAFE BUILDINGS, AND GENERAL OPERATIONS AND SERVICES OF THE CITY INCLUDING THE POLICE DEPARTMENT FOR A PERIOD OF FIVE YEARS COMMENCING JANUARY 1, 2021 AND DECLARING AN EMERGENCY.

# **Second Reading**

Mayor Evans wanted to again explain the tax levy. RITA has estimated it will bring in million a year. In the past we have moved 1-1.2 million from the electric fund to the general fund, and the state auditor has told us we can't do any longer. We have been able to remove the 3% water and sewer increase for Jackson citizens. The electric rate ordinance will be up for the next regular meeting and will be cutting rates by 10%. Half of the money that that will be brought in from the tax levy will be used for infrastructure repair and replacement of buildings, streets, sidewalks, and underground repairs. These things have been neglected for 10-12 years. The other half will go to the general operations of the city including the police department. This levy is only for 5 years.

Mr. Coll asked since we are not proposing to increase the cemetery tax levy, should we make provisions to the income tax levy to cover the cemetery.

Mrs. Biggs asked are the water, sewer, and cemetery not enough to be self sufficient? Should we charge more for burial?

Mr. R. Peters said we just doubled burial rates last year. He doesn't feel we could raise rates again.

Mayor Evans said the tax Levy covers infrastructure of the city. The cemetery is part of the city. So it would cover repairs to the cemetery.

This levy keeps the police at its current level.

There was discussion over a tax credit for people who work in another city but live in Jackson. Mayor Evans said in 2018 they offered a 100% credit with a limit of 1%.
