- When looking at which streets to do, they have to consider the storm catch basins, gutters, curbs...ect
- Also, looking at the sewer line repairs and how they will affect what streets they do also. They
 don't want to pave a street and then have to tear it up to work on the sewer lines.

- Marcia Eggers spoke about the cemetery. She said she buried her 18-year-old son there, and feels it is not right to put a sign by his grave saying things had to be removed. She mows or weed eats when necessary. She takes good care of the plot.
- Laydene Orender agrees with Marcia. Her son and husband are buried there. The city doesn't take care of the plots. They had knocked off a stainless steel plate from her son's headstone when mowing and didn't put it back. She asked council to reconsider allowing them to continue taking
- Vicky Coy addressed council again. She understands the ordinances do go back to before she bought her plots. However, she said things can be changed. There has to be a way to resolve this without removing everything.
- Mayor Evans apologized for offending people. Those signs were placed by city employees. They had to use their own judgment on where to place them. He said nothing is mentioned about
- Mr. Swackhammer said we need to regroup and look at this. It's been a discussion for 6 months. He said city cemetery workers need to have a voice in this as well.
- Mr. R. Peters suggested we see what other cemeteries are doing and change ours if necessary.
