- In 2019, there were two paved roads in the cemetery. None were done in 2020. There is one in 2021 scheduled for next month. The rest will be completed in 2022. The website has highlighted map showing these areas.
- Small signs will be planted on the cemetery lots this week to bring the plots into compliance. They will have until September 30, 2021 to comply or the city will enforce the 2010 ordinance.




