CORRESPONDENCE ~ None

OLD BUSINESS ~ Mr. Foster said he would like to talk to Chief Hinsch about the traffic study and then with Mr. Swackhammer. He has not been able to do this yet. Mr. Peters asked if there is anything we can do in the mean time regarding the Bridge St. requests. A petition is in the packets tonight signed by several residents in the area. Mr. Ondera said he thought making another change would add to the confusion. He understands Chief Hinsch has helped Mr. Entler with getting his camper into his driveway. They are trying to resolve that situation for him. He understands there are other concerns.

Mr. Entler said he has watched and everyday people are starting and stopping and do not know what to do at the intersection now. He agrees it would cause more confusion and probably be dangerous if it were changed again right now.

Mr. Peters asked which is more cost effective: the traffic study or fixing the light. Mr. Swackhammer said the light would be cheaper, but there are several lights in the city that might need removed to improve the traffic flow. The study will resolve all the issues. Wouldn't want to fix this light, do the traffic study, and then decide to remove the light again.

Mr. Foster asked if Mr. Swackhammer had been able to talk to the railroad owner about the rough tracks on Carr St. by Veteran's Drive. Mr. Swackhammer said he did not. He would make a note to do that.

NEW BUSINESS ~ Mr. Peters said the Planning Commission will be recommending some amendments to the verbiage in the Zoning Book. They will likely bring legislation to the next meeting for council to approve to do this.

Mr. Ondera asked if there were any other questions or ideas regarding the Rumpke meeting.
