**SERVICE DIRECTOR**

- ODOT has been working on Main St. on the traffic signal sections. They are working underground for 2-3 weeks doing the signal upgrade itself. They have large reflector back plates to put on the arms. The arms have to be raised because this now causes the plates to be too low. New poles have to be placed into the ground to raise the arm height. They could not just raise the arm.
