SIGNED IN VISITORS TO SPEAK~ Mr. Camp spoke in regards to the resolution concerning vacating the alleys between his properties and Circle Dr. He is trying to deed three lots into two so his sons can build houses on them. The one alley is all grass. The surveyor cannot do this until the alley is vacated. He also wants part of the street vacated. It dead-ends into a guardrail. He said people often come down that way and get turned around. They get stuck at the guardrail and have to back into his property, often his yard to get turned around to leave.
