Today they started as Operations Managers. They will manage multiple city departments from the field.

These new positions will improve services to the city, make city operations more efficient and more cost effective, and improve public perception and staff morale.

Mayor Evans clarified that we are not adding new jobs or more payroll to the city. In 2019 when Mayor Evans was elected there were 70 Full Time employees not counting the PD. Now there are 61. In 2019, ten of these were at the superintendent level and above. At the end of this year, there will be only six. This is a savings of payroll and benefits of over ½ million dollars each year. These 61 employees continue to provide great service to our citizens and local businesses. The mayor thanked council for being a part of the improvements and changes.

CORRESPONDENCE~ Clerk gave a final reminder on the Financial Disclosure Deadline for the paperwork that needs filed by all council members and other elected officials. OLD BUSINESS~

- Mr. Peters asked about the plans for Hammertown Lake. Mr. Swackhammer said there have been straw bales placed for the silt collection and runoff. There is grass growing in the seeded area. They have added these precautionary measures although they didn't feel there was a risk.
- FOP withdrew their application. Do we have plans for stocking the lake with fish other than Trout? Mayor Evans said they met today with the Fire Chief and FOP president. There will not be a Trout Festival. They are planning to have a fishing tournament in May. They hope the JHS Bass Fishing Team will join along with the Oak Hill team and other county departments. They have reached out to ODNR about stocking with something else.

NEW BUSINESS~

- Mr. Bopp asked about incorporating citizens in the clean-up of the cemetery during the city-wide clean-up day. There are limbs down and flowers blown everywhere from the storm. Mr. Swackhammer said two full time employees have been working on the clean up at the cemetery. He said anyone who normally maintains a relative's gravesite up there knows that everything is blown away and there is no way to know which site it goes with. It will end up in the dumpster there.
- They are taking applications for seasonal work up there. He said they usually have enough workers for the summer months, but could use more help in the months before school lets out and when students go back to school. If there is anyone interested in working in the cooler months and not the hot summer to reach out to him.


