ORDINANCE NO. 87-06

AN ORDINANCE AUTHORIZING THE CITY TO ENTER INTO AN AGREEMENT WITH JACKSON COUNTY FOR TENANT BASED RENTAL ASSISTANCE, AND DECLARING AN EMERGENCY.

WHEREAS, the Jackson County is proposing a Tenant-Based Rental Assistance (TBRA) program through the FY 2006 CHIP Grant; and

WHEREAS, some of the program may occur in the City of Jackson, Ohio; and

WHEREAS, in order for the program to occur within the City of Jackson it is necessary to enter into a cooperative agreement; and

WHEREAS, the City now desires to enter into a cooperative agreement with Jackson County for Tenant-Based Rental Assistance.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF JACKSON, STATE OF OHIO, as follows:

<u>Section One.</u> The Mayor or his designated representative is authorized to enter into a Cooperative Agreement between the City of Jackson, Ohio and Jackson County for Tenant-Based Rental Assistance Program. A copy of the Assignment of Lease Agreement is attached hereto as Exhibit "A".

Section Two. This Ordinance is hereby declared to be an emergency Ordinance necessary for the immediate preservation of the public peace, health, or safety of the City of Jackson, in that it is necessary to enter into this Agreement as soon as possible in order for the Tenant-Based Rental Assistance Program to proceed in a timely manner. Therefore, this Ordinance shall go into effect upon passage and approval by the Mayor, as provided in Ohio Revised Code Section 731.30.

<u>Section Three.</u> In the event this Ordinance receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, then this Ordinance shall be deemed to have passed but with no emergency clause and shall take effect at the earliest time permitted by law.

<u>Section Four.</u> It is hereby found and determined that all formal actions of this Council relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that the deliberations of this Council that resulted in such formal actions, were in a meeting open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
