ORDINANCE NO. 96-06

AN ORDINANCE AUTHORIZING THE CITY TO PURCHASE THROUGH STATE PURCHASING A VERMEER BRUSH CHIPPER FROM VERMEER OF SOUTHERN OHIO, INC., 2574 U.S. ROUTE 22, WASHINGTON, C.H., OHIO 43160, AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF JACKSON, STATE OF OHIO, as follows:

Section One. Council hereby authorizes the purchase of a new Vermeer Brush Chipper from Vermeer of Southern Ohio, Inc., 2574 U.S. Route 22, Washington, C.H., Ohio 43160. This purchase shall be through state purchasing and shall be for one Vermeer Brush Chipper. The purchase price is authorized in the amount of Thirty Two Thousand Seven Hundred Seventy Three and No/100 Dollars (\$32,773.00), less a \$12,000.00 trade in of the City's old Brush Chipper, for a total of Twenty Thousand Seven Hundred Seventy Three and No/100 Dollars (\$20,773.00). This contract shall be paid from line item number 731-7555-54002.

Section Two. The Mayor and/or his designated representative is hereby authorized to execute this Contract in accordance with state purchasing requirements.

Section Three. This Ordinance is hereby declared to be an emergency Ordinance necessary for the immediate preservation of the public peace, health, or safety of the City of Jackson, in that it is necessary to purchase this new Brush Chipper as soon as possible in order to provide the proper tolls fro the City to perform the services. Therefore, this Ordinance shall go into effect upon passage and approval by the Mayor, as provided in Ohio Revised Code Section 731.30.

<u>Section Four.</u> In the event this Ordinance receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, then this Ordinance shall be deemed to have passed but with no emergency clause and shall take effect at the earliest time permitted by law.

Section Five. This Council finds and determines that all formal actions of this Council concerning and relating to the passage of this ordinance were taken in an open meeting of this Council and that all deliberations of this Council that resulted in those formal actions were in meetings open to the public, all in compliance with the law.






