## ORDINANCE NO. 165-07

AN ORDINANCE APPROVING ADDITIONAL APPROPRIATIONS IN THE GENERAL FUND, AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF JACKSON, STATE OF OHIO, as follows:

**Section One.** The original appropriation ordinance, as it relates to the General Fund is hereby modified so as to appropriate additional moneys as follows:



**Section Two.** This Ordinance is hereby declared to be an emergency Ordinance, necessary for the immediate preservation of the public peace, health or safety of the City of Jackson, in that it is necessary to modify appropriations immediately so that payments can be timely made in accordance with the contract between the City and the FOP. Therefore, this Ordinance shall go into effect upon passage and approval by the Mayor, as provided in Ohio Revised Code Section 731.30.

**Section Three.** In the event this Ordinance receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, then this Ordinance shall be deemed to have passed but with no emergency clause and shall take effect at the earliest time permitted by law.

**Section Four.** In is hereby found and determined that all formal actions of this Council relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that the deliberations of this Council that resulted in such formal actions were in a meeting open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Wendy,

Bonnie brought over the approved sheet for the police educational incentive that is scheduled to be paid out on 12/12/07. The total is \$6000 and there is only \$900 left in the line item. There are probably two reasons for the shortage. First, the police contract wasn't settled until 4/07 and there was an increase in what is allowable for the officers which was paid out in 2007. Secondly, it appears that there may be more officers entitled to the educational incentive and several officers have gotten additional training.
