ORDINANCE NO. 171-07

AN ORDINANCE CORRECTING ORDINANCE NO. 163-07, FINDING THE LOWEST RESPONSIBLE AND RESPONSIVE BID, AWARDING THE CONTRACT FOR THE WOOD AVENUE SANITARY SEWER LINING PROJECT, TO KOKOSING CONSTRUCTION COMPANY, INC., 17531 WATERFORD ROAD, FREDERICKTOWN, OHIO 43019, AND DECLARING AN EMERGENCY.

WHEREAS, Ordinance No. 163-07, which was passed and adopted by Jackson City Council on November 26, 2007, contained a scrivener's error in the amount of the contract; and

WHEREAS, Ordinance No. 163-07 incorrectly stated the amount of the contract to be \$169,841.00, when the correct amount is \$161,841.00; and

WHEREAS, Jackson City Council desires to correct the amount to state \$161,841.00, and to award the contract to Kokosing Construction Company, Inc., which was the lowest responsible and responsive bid on the contract.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF JACKSON, STATE OF OHIO, as follows:

Section One. Council reaffirms that Kokosing Construction Company, Inc., 17531 Waterford Road, Fredericktown, Ohio 43019, is the lowest responsive and responsible bidder for the Wood Avenue Sanitary Sewer Lining Project, that the contract has been lawfully advertised and bid, and the lowest responsive and responsible bid is in the amount of One Hundred Sixty-One Thousand Sixty-eight and 00/100 Dollars (\$161,841.00). This contract shall be paid from line item 439-7525-53064: Construction Costs: Wood Avenue Sanitary Sewer Lining Fund.

<u>Section Two.</u> The Mayor or the Service Director is hereby authorized to execute this Contract and any financing documents according to the terms of the lowest responsive and responsible bid.

<u>Section Three.</u> This Ordinance is hereby declared to be an emergency Ordinance necessary for the immediate preservation of the public peace, health, or safety of the City of Jackson, in that it is necessary to accept this bid as soon as possible to receive the bid price, and in order to commence with this project as soon as possible. Therefore, this Ordinance shall go into effect upon passage and approval by the Mayor, as provided in Ohio Revised Code Section 731.30.

<u>Section Four.</u> In the event this Ordinance receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, then this Ordinance shall be deemed to have passed but with no emergency clause, and shall take effect at the earliest time permitted by law.
