**ORDINANCE NO. 95-08**

AN ORDINANCE AUTHORIZING THE CITY TO ENTER INTO A CONTRACT WITH MORTON THIOKOL, 123 N. WACKER DRIVE, CHICAGO, ILLINOIS 60606, TO PROVIDE ROAD SALT FOR THE 2008-2009 WINTER SEASON, AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF JACKSON, STATE OF OHIO, as follows:

**Section One.** The Service Director is hereby authorized to enter into an Agreement with Morton Thiokol, 123 N. Wacker Drive, Chicago, Illinois 60606, to purchase road salt for the City's streets for the 2008-2009 winter season. The amount of this agreement shall be in an amount of Forty Four Thousand and No/100 Dollars (\$44,000.00), and shall be paid from the following line items:

223-7615-54004 (Permissive Tax Fund - Streets, Highways & Sidewalks)	\$ 22,000.00
222-7610-54004 (Street C.M.&R. Fund - Streets, Highways & Sidewalks)	\$ 22,000.00

**Section Two.** This Ordinance is hereby declared to be an emergency Ordinance, necessary for the immediate preservation of the public peace, health or safety of the City of Jackson, in that it is necessary to approve this additional appropriation in order that the pricing for the road salt is scheduled to increase and the quoted price is good for ten days. Therefore, this Ordinance shall go into effect upon passage and approval by the Mayor, as provided in Ohio Revised Code Section 731.30.

**Section Three.** In the event this Ordinance receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, then this Ordinance shall be deemed to have passed but with no emergency clause and shall take effect at the earliest time permitted by law.

**Section Four.** It is hereby found and determined that all formal actions of this Council relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that the deliberations of this Council that resulted in such formal actions were in a meeting open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
