ORDINANCE NO. 75-09 *AS AMENDED*

AN ORDINANCE AMENDING JACKSON CODIFIED ORDINANCE SECTION 929.07 – WATER RATES, AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF JACKSON, STATE OF OHIO, as follows:

Section One. The Jackson Codified Ordinance Section 929.07 is hereby amended as set forth in Exhibit “A”.

Section Two. The Clerk of Council shall assure that this Ordinance is posted in all the City’s Ordinance books.

Section Three. This Ordinance is hereby declared to be an emergency Ordinance, necessary for the immediate preservation of the public peace, health or safety of the City of Jackson, in that it is necessary to adopt this amended codified ordinance section to insure the receipt of funding for improvements to the City’s water infrastructure. Therefore, this Ordinance shall go into effect upon passage and approval by the Mayor, as provided in Ohio Revised Code Section 731.30.

Section Four. In the event this Ordinance receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, then this Ordinance shall be deemed to have passed but with no emergency clause and shall take effect at the earliest time permitted by law.

Section Five. It is hereby found and determined that all formal actions of this Council relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that the deliberations of this Council that resulted in such formal actions were in a meeting open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
