The Comstock building is the only building we have demolished this year, and this will still leave \$2,500 in the fund. Hopefully, we can hold off addressing that downtown building on Broadway until next year.

Outside Legal Expenses 110-7740-53022 \$35,000

Law Director Jack Detty told me following the Aug. 10 council meeting that because the insurance company picked up some of our legal representation, he would not be needing all of his outside legal expense money this year and if it was council's wishes, he was willing to allow it to go to the administrative line item, and would still leave him \$16,000-plus in this account. The administration has also agreed to assist Mr. Detty in a couple of particular areas of need for his office that should help both of our offices to be more efficient and effective.

This would come out to \$60,000, which is a little over \$2,000 more than we would need.

You said that all of these funds were available. If anything has changed, please let me know.

Also, you might want to remind Jack we need to bring back an ordinance that had the information in it that Ordinance 60-09 had, transferring the money into the administrative services line in the general fund.
