ORDINANCE NO. 100-09

AN ORDINANCE TO MOVE APPROPRIATIONS, AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF JACKSON, STATE OF OHIO, as follows:

Section One. City appropriations are hereby moved as follows:

FROM	AMOUNT	AMENDED APPROPRIATION
GENERAL FUND - GENERAL GOV'T. 110-7750-53019	(\$ 4,000.00) (Independent Auditor Fees)	\$ 38,900.00

TO	AMOUNT	AMENDED APPROPRIATION
GENERAL FUND - FIRE DEPT. 110-7115-52010	\$ 4,000.00 (Salaries & Wages)	\$ 8,124.21

Section Two. This Ordinance is hereby declared to be an emergency Ordinance, necessary for the immediate preservation of the public peace, health or safety of the City of Jackson, in that it is necessary to approve the moving of these appropriations in order that the payroll and other expenses can be paid in a timely manner. Therefore, this Ordinance shall go into effect upon passage and approval by the Mayor, as provided in Ohio Revised Code Section 731.30.


Section Three. In the event this Ordinance receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, then this Ordinance shall be deemed to have passed but with no emergency clause and shall take effect at the earliest time permitted by law.
