



ORDINANCE NO. 129-10

AN ORDINANCE APPROVING ADDITIONAL APPROPRIATIONS IN THE WATER FUND, AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF JACKSON, STATE OF OHIO, as follows:

Section One. The appropriation ordinance, as it relates to the Water Fund, is hereby modified so as to appropriate additional moneys as follows:
