Section One. The Service Director is authorized to enter into an Agreement between the City of Jackson, Ohio, and The Jackson Bowhunters Club (JBC), to allow JBC use of certain property in the Hammertown Lake area. A copy of the Agreement is attached hereto as Exhibit "A". This Ordinance is hereby declared to be an emergency Ordinance necessary for Section Two. the immediate preservation of the public peace, health, or safety of the City of Jackson, in that it is necessary to enter into this agreement as soon as possible in order that JCB may continue its use of City property for club activities. Therefore, this Ordinance shall go into effect upon passage and approval by the Mayor, as provided in Ohio Revised Code Section 731.30. Section Three. In the event this Ordinance receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, then this Ordinance shall be deemed to have passed but with no emergency clause and shall take effect at the earliest time permitted by law. It is hereby found and determined that all formal actions of this Council relating Section Four. to the adoption of this Ordinance were adopted in an open meeting of this Council, and that the deliberations of this Council that resulted in such formal actions, were in a meeting open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code. Exhibit "A"

LICENSE AGREEMENT

This License Agreement ("Agreement") is entered into between the City of Jackson, Ohio ("City") and the Jackson Bowhunters Club ("Club") in Jackson County, Ohio, on the date indicated below, under the following circumstances:

- a: Both parties wish to continue the Club's previous right to use the real property describe in Exhibit A, attached hereto (the :Real Property"); and
- b: Both parties wish to assure that the Club assumes responsibility for its own activities.

Therefore, in consideration of their mutual promises and other valuable consideration, the parties agree as follows:

- 1. <u>License to Use the real Property</u>. The City grants to the Club the right to use the Real Property for its Club activities (the "License").
- 2. <u>Term of License</u>. The License shall commence on the date the City executes this Agreement and shall extend for a period of ten years, unless Agreement is sooner terminated.
- 3. License Fee. There shall be no fee or rent for the License.
- 4. <u>No connection to Club.</u> The City shall have no control over or connection with the Club, except as herein expressly agreed.
- 5. <u>Maintenance</u>. The Club shall maintain the Real Property in a safe and attractive condition. In particular, the Club shall mow the Real Property at least twice each year.
- 6. <u>Safety Obligation</u>. The Club shall exercise its best efforts to conduct its activities, including archery, in a safe manner. In particular, the Club shall conduct its archery range activities under the strict supervision of qualified range officer or instructors.

- 7. <u>Hold Harmless Obligation</u>. The Club shall hold the City harmless from any and all personal injury, including death, occurring on the Real Property or anywhere else as a result of Club activities.
- 8. <u>Liability Insurance</u>. To secure the Hold Harmless Obligation, the Club shall obtain and pay for liability insurance covering the risks described in Paragraph 7, above, with the amount of coverage in the amount of at least One Million Dollars (\$1,000,000.00). The City shall be named insured in this policy. The Club shall present evidence of this paid up insurance coverage at least annually to the City.
- 9. <u>Termination</u>. Either party may terminate this Agreement upon thirty (30) days' written notice delivered to the other party.
- 10. <u>Notice Addresses</u>. The City's mailing address for notice purposes shall be Service-Safety Director, City of Jackson, Ohio, Municipal Building, 145 Broadway Street, Jackson, Ohio 45640. The Club's mailing address for notice purposes shall be c/o Beau S. Kearns, President, P.O. Box 396, Jackson, Ohio 45640. (740-286-1988), or whatever other address the Club indicates in writing to the City.
- 11. <u>Authority to Execute Agreement</u>. The City is authorize to enter into this Agreement by City Council's Ordinance No. <u>(c) (-/(d)</u>, adopted on 2010. The Club is an unincorporated association which is authorized by its governing body to enter into this Agreement.


