## ORDINANCE NO. 75-10

AN ORDINANCE AUTHORIZING THE TRANSFER OF THE 1981 CHEVROLET CHASSIS, PIERCE FIRE BODY MINI-PUMPER TO THE JACKSON FIREFIGHTER'S ASSOCIATION, AND DECLARING AN EMERGENCY.

WHEREAS, several years ago the Jackson Firefighters Association purchased a 1981 Chevrolet Chassis, Pierce Fire Body mini-pumper to be used by the Jackson City Fire Department; and

WHEREAS, the Firefighter's Association titled the mini-pumper to the City of Jackson, Ohio; and

WHEREAS, recently Jackson City Council authorized the purchase of a new mini-pumper for the Fire Department, thus replacing the 1981 model; and

WHEREAS, it is in the best interests of the City to return title of the 1981 mini-pumper to the Firefighters Association in order that they may sell the mini-pumper and use the proceeds to help assist the Jackson City Fire Department.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF JACKSON, STATE OF OHIO, as follows:

**Section One.** The Safety/Service Director is hereby authorized to sign any and all appropriate paperwork and documents to transfer ownership of the 1981 Chevrolet Chassis, Pierce Fire Body mini-pumper to the Jackson Firefighters Association in order the Firefighters Association may sell the mini-pumper and use the proceeds of the sell to benefit the Jackson City Fire Department. This transfer is considered part of the agreement wherein the Jackson City Council authorized the purchase of a new mini-pumper to replace the 1981 model.

**Section Two.** The Safety/Service Director is hereby authorized to execute any necessary documents to transfer title to the 1981 mini-pumper to the Firefighters Association.

**Section Three.** This Ordinance is hereby declared to be an emergency Ordinance necessary for the immediate preservation of the public peace, health, or safety of the City of Jackson, in that it is necessary to accept this bid as soon as possible in order that the Firefighters Association may proceed to sell the mini-pumper to raise funds to support the Jackson City Fire Department. Therefore, this Ordinance shall go into effect upon passage and approval by the Mayor, as provided in Ohio Revised Code Section 731.30.

**Section Four.** In the event this Ordinance receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, then this Ordinance shall be deemed to have passed but with no emergency clause, and shall take effect at the earliest time permitted by law.

**Section Five.**

This Council finds and determines that all formal actions of this Council concerning and relating to the passage of this ordinance were taken in an open meeting of this Council and that all deliberations of this Council that resulted in those formal actions were in meetings open to the public, all in compliance with the law.
