ORDINANCE NO. 47-13

AN ORDINANCE OF THE LEGISLATIVE AUTHORITY OF THE CITY OF JACKSON, OHIO TO ACCEPT THE BID OF QUALITY LINES, INC. FOR THE 13.2kV CIRCUIT 3 AND 3A CONVERSION PROJECT FOR AN AMOUNT NOT TO EXCEED \$1,817,207 AS IT WAS THE LOWEST AND BEST RESPONSIVE BID SUBMITTED AND DECLARING AN EMERGENCY.

WHEREAS, in response to a request for bids for a 13.2kV circuit 3 and 3A conversion project for the City of Jackson, bids have been reviewed and a determination has been made as to the lowest and best responsive bid; and

WHEREAS, it has been determined that the lowest and best responsive bid was from Quality Lines, Inc., P.O. Box 904, Findlay, Ohio 45839, for the 13.2kV circuit 3 and 3A conversion project for a cost of \$1,817,207.00; and

WHEREAS, the immediate passage of this ordinance constitutes an emergency for the reason that the completion of the conversion project at the earliest date will be beneficial to the operation of the City's electric system and is necessary for the preservation of the public's health, safety and welfare.

NOW, THEREFORE, BE IT ORDAINED AS FOLLOWS:


Section 1. The legislative authority of the City of Jackson hereby authorizes the Mayor or Director of Service and Public Safety of the City of Jackson, Ohio to accept the bid submitted by Quality Lines, Inc. for a maximum cost of \$1,817,207.00 to be paid from line item #731-7555-54005.

Section 2. This matter is hereby declared to be an emergency necessary for the immediate preservation of the public peace, health or safety of the City of Jackson, Ohio.

Section 3. In the event this Ordinance receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, then this Ordinance shall be deemed to have passed but with no emergency clause, and shall take effect at the earliest time permitted by law.

It is hereby found and determined that all formal acts of this council concerning and relating to adoption of this Ordinance were adopted in an open meeting of this council and that the deliberations of the council and any of its committees resulted in such formal action, wherein meeting open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
