## ORDINANCE NO. 35-15

AN ORDINANCE OF THE LEGISLATIVE AUTHORITY OF THE CITY OF JACKSON, OHIO DIRECTING THE DIRECTOR OF SAFETY AND SERVICE TO ENTER INTO AN AGREEMENT WITH SJM CONSTRUCTION, LLC FOR THE REPAIR OF THE ROADWAY AND STORM SEWER ON MARKHAM DRIVE AND DECLARING AN EMERGENCY.

WHEREAS, there has been extensive damage to Markham drive and the City must immediately repair the storm sewer on Markham Drive and to complete repair of the road so as to make it usable and to prevent further damage; and

WHEREAS, the City has requested proposals from multiple companies having the expertise to complete the work required and did advertise the request in a local newspaper as time permitted; and

WHEREAS, the lowest and most responsive proposal was from SJM CONSTRUCTION, LLC to complete the work requested for an amount not to exceed \$58,850.00; and

WHEREAS, this matter constitutes a real and present emergency for the reason that immediate repair of the problem is required and this repair is necessary for the preservation of the health, safety and welfare of the City of Jackson and its residents and that, under the authority of R.C. 735.051, the conditions obviate requirements for formal bidding and advertising for contracts

NOW, THEREFORE, BE IT ORDAINED AS FOLLOWS:

<u>Section 1.</u> The legislative authority of the City of Jackson hereby authorizes the Director of Service and Public Safety of the City of Jackson, Ohio to enter an agreement with SJM CONSTRUCTION, LLC for an amount not to exceed \$58,850.00.

<u>Section 2.</u> This matter is hereby declared to be an emergency necessary for the immediate preservation of the public peace, health or safety of the City of Jackson, Ohio.

It is hereby found and determined that all formal acts of this council concerning and relating to adoption of this Ordinance were adopted in an open meeting of this council and that the deliberations of the council and any of its committees resulted in such formal action, wherein meeting open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
