## **ORDINANCE NO. 47-15**

AN ORDINANCE AUTHORIZING THE MAYOR OR HIS SERVICE AND SAFETY DIRECTOR TO ADVERTISE FOR SALE THE 1995 E-ONE AERIAL LADDER TRUCK NOW OWNED BY THE CITY BUT NO LONGER NEEDED FOR A MUNICIPAL PURPOSE, TO BE SOLD TO THE BEST BIDDER PURSUANT TO R.C. SECTION 721.15.

WHEREAS, the City of Jackson is the owner of a 1995 E-One Aerial Ladder Truck, VIN 4ENBAAA8951005212, hereinafter referred to as the "property".

WHEREAS, the City finds that the property is not needed for a municipal purpose by the City of Jackson, Ohio and that it is in the best interest of the City that it be sold in accordance with R.C. 721.15(A) or (B).

WHEREAS, the City has acquired a vehicle to replace the property and, upon delivery of the new vehicle, the City lacks space to protect and safely store both vehicles and any delay in sale of the property will place the vehicle at risk of damage and further depreciation in value so that this matter constitutes an emergency to protect the safety, health and welfare of the City.

WHEREAS, the Legislative Authority finds that the City would be better served to sell or trade-in the property so as to obtain the greatest price from either: 1) the highest bidder after being advertised for not less than two consecutive weeks nor more than four consecutive weeks in a newspaper of general circulation within the City of Jackson or; 2) as the City is simultaneously seeking to purchase a new truck through State bid purchasing procedure, a seller of a new truck who may offer to accept the property in partial trade for a new truck to be purchased by the City, wherein the trade-in value shall be credited to the purchase price.

NOW, THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE AUTHORITY OF THE POLITICAL SUBDIVISION OF CITY OF JACKSON, OHIO, THAT THE SAID 1995 E-ONE AERIAL LADDER TRUCK BE ADVERTISED FOR SALE FOR A PERIOD OF NOT LESS THAN TWO CONSECUTIVE WEEKS NOR MORE THAN FOUR WEEKS, IN A NEWSPAPER OF GENERAL CIRCULATION WITHIN THE CITY OF JACKSON AND THAT THE PROPERTY ALSO BE OFFERED AS A TRADE-IN TO A SELLER OF A NEW FIRE VEHICLE WITH THE VALUE BEING CREDITED AGAINST THE PURCHASE COST OF SAID VEHICLE AND THAT THE PROPERTY BE SOLD OR TRADED TO THE HIGHEST BIDDER AND DECLARING AN EMERGENCY.

OPEN MEETING. It is hereby found and determined that all formal actions of this council concerning and relating to this Ordinance were adopted in an open meeting, and that these deliberations of this council and its committees resulted in such formal action, or in meeting open to the public, in compliance with all legal requirements including section 121.22 of the Ohio Revised Code.
