ORDINANCE NO.21-15

AN ORDINANCE REPEALING AND REVISING SECTION 557.04 OF THE CITY OF JACKSON CODE OF ORDINANCES SO AS TO INCREASE THE AMOUNT CHARGED FOR THE CITY MOWING PRIVATE LOTS TO A MINIMUM CHARGE OF \$250.00.

WHEREAS, Section 557.04 of the Codified Ordinances of the City of Jackson presently sets the minimum charge for the City mowing private property at \$150.00; and

WHEREAS, the legislative authority of the City of Jackson has determined it necessary to increase the minimum charge for private lots mowed by the City to a minimum of \$250.00; and

NOW, THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE AUTHORITY OF THE POLITICAL SUBDIVISION OF THE CITY OF JACKSON, OHIO THAT THE FOLLOWING BE AN ORDINANCE SETTING THE MINIMUM FEE CHARGED FOR THE CITY TO MOW PRIVATE LOTS AT \$250.00, AN INCREASE FROM \$150.00, AS SET FORTH BELOW WITH THOSE UNDERLINED AND CAPITALIZED PORTIONS SHOWING THE AMENDMENTS TO THE ORGINAL LANGUAGE AND THAT IT BE NUMBERED AS SECTION 557.04 AND REPLACED WITHIN THE JACKSON CITY CODE, IN REGULAR TEXT, AS FOLLOWS:

557.04 CITY MAY TAKE ACTION.

If the owner, lessee, or person having charge of the land fails to comply with the notice provided for in Section 557.02, the Mayor, or his designated representative, shall cause noxious weeds, high grass, high weeds and rank vegetation to be mowed, cut and destroyed. In the event the City takes action it may employ the necessary labor to perform the task. All expenses and labor costs incurred, shall be paid out of City funds not otherwise appropriated. The charge for the City mowing, cutting or destroying the noxious weeds, high grass, high weeds and rank vegetation shall be no less than one hundred fifty dellars (\$150.00) TWO HUNDRED FIFTY DOLLARS (\$250.00).

It is hereby found and determined that all formal actions of this Council concerning and relating to adoption of this ordinance were adopted in an open meeting of this Council and the deliberations of this Council and any of its committees that resulted in such formal action were in a meeting open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
